Purpose of Report

1. To seek delegation of powers in respect of the Supporting People Service to the Director of Community Services.

In respect of Supporting People:-

1.	Make payments of Supporting People grant in accordance with Supporting People Grant Conditions.	No	
2.	Consider requests for backdated subsidy where the client has been awarded backdated Housing Benefit or a backdated Fairer Charging Assessment.	No	
3.	Award payment of subsidy for clients in receipt of Housing Benefit or a Fairer Charging Assessment in accordance with the Supporting People Charging Policy.	No	
4.	Consider written requests for revisions of award of subsidy by carrying out an internal review, in accordance with the Supporting People Charging Policy.	No	
5.	Identify overpayments of subsidy and use discretion in the recovery of overpayments.	No
