Foreword

Welcome to Darlington's 8th Carers' Strategy and Implementation Plan, which for the first time is a 3 year Strategy, which runs to March 2011.

This year has seen the long awaited publication of the second National Carers Strategy, <u>Carers at the heart of 21st century families and communities "A caring system at your side. A life of your own"</u>, the first National Carers Strategy having been published in 1999.

Darlington's Carers' Strategy and Implementation Plan builds on this second National Carers Strategy and on the commitments and successes of previous local Carers' Strategies and Implementation Plans. It will also help us to achieve the vision within the Sustainable Community Strategy 'One Darlington: Perfectly Placed', in which carers are acknowledged as one of the groups who are particularly at risk of discrimination, deprivation and disadvantage.

I am pleased to say that as part of the growing commitment to carers in Darlington, I have been asked to take on the role of Carers' Champion, as all too often the vital role that carers play is unrecognised and undervalued.

I would like to take this opportunity to acknowledge publicly the vital contribution that carers make while caring for their family member, friend or neighbour, often while continuing to fulfill their other commitments, such as holding down a job and bringing up children. Darlington Borough Council is committed to continuing to support carers in this role by working with all partners to develop services which enable them to continue to carry out this invaluable role while still being able to live a life of their own.

I look forward to championing the cause of carers in Darlington.

1. Introduction

This is our first 3 year Carers' Strategy and Implementation Plan and is set out slightly differently from previous annual strategies. It continues to include information from the 2001 census and up to date information about the number of carers we know about in Darlington. It also includes a new section on issues affecting carers of specific user groups and an expanded section on the types of support available to local carers.

It should be read in the context of Darlington's Sustainable Community Strategy 'One Darlington: Perfectly Placed. A Vision for Darlington: 2008- 2021', which identifies 5 delivery themes:

- Prosperous Darlington
- Aspiring Darlington
- Healthy Darlington
- Greener Darlington
- Safer Darlington

The Carers' Strategy will have a particular impact in relation to the Aspiring Darlington and Healthy Darlington themes.

More information about the Sustainable Community Strategy is attached as Appendix 2.

a) Consultation Process

Development of the Carers' Strategy and Implementation Plan is led by members of the Carers' Strategy Steering Group. This was first established in 1999 in order to identify actions to be taken locally to meet the objectives laid out in the first National Strategy for Carers. Since this time, the Group has continued to meet to oversee further Carers' Strategies and implementation Plans.

The Group consists of representatives from the following organisations:

- Darlington Borough Council Adult Social Care and Children's Services
- County Durham and Darlington Foundation Trust

- Tees, Esk and Wear Valleys NHS Foundation Trust
- Darlington Primary Care Trust
- Voluntary sector
- DAD Carers Support Service
- Carers in Darlington

Details of current Group membership are attached as Appendix 4.

In addition, a further 52 carers and 9 members of staff from partner organisations also receive minutes.

The aim of the Group is to work in partnership in order to develop a more integrated model of care that fully acknowledges the needs and aspirations of carers of all service user groups.

The Group encourages engagement from carers in a variety of ways, such as attendance at meetings and receiving minutes, in order to ensure that carers' views are incorporated into service planning and delivery. Carers' pre-meetings, to enable carers to raise and discuss non – strategic issues and to prepare for the Strategic meeting, have also started to take place this year.

In addition, information about the draft Strategy has been included in a variety of media including a number of newsletters, the Town Crier, Northern Echo and on the Council's website.

b) Equality Impact Assessments

Equality and Disability Equality Impact Assessments have been completed as part of drawing up the Carers' Strategy and Implementation Plan.

Although it is likely that in many instances services that support carers will impact positively on disabled people, it is acknowledged that on some occasions, the needs of carers and the needs of the disabled people that they care for may be in conflict. The intention of the Strategy and Implementation Plan is to ensure that the actions taken to support carers are undertaken in such as way as to maximise positive impacts on disabled people and to minimise any negative impacts that may occur. Further impact assessments may be undertaken as necessary in relation to any of the Implementation Plan actions.

2. Who is a Carer?

Carers are family, friends or neighbours who provide physical, practical or emotional care or supervision to another person, as a result of that person's age, frailty, mental or physical health needs or learning disabilities. People often find it difficult to see themselves in this role and may not want to be called a carer, seeing themselves as primarily as a son, daughter, husband, wife etc.

Young Carers are carers under the age of 18. The person receiving care is often a parent but can also be a brother or sister, grandparent or other relative who needs support because of a health problem or disability.

Parent Carers are those with parental responsibility for a disabled child. Parents will often see themselves primarily as parents but their child will have additional care needs and may be entitled to additional services.

The level of care provided may range from a few hours per week to more than 50 hours per week. Some carers provide 24 hour care to the person they are caring for.

This Strategy covers all of the above groups of carers, and should be read in conjunction with the Young Carers' Action Plan 2007-09 (and subsequent Young Carers' Action Plans), and the Parent Carers Action Plan which will be developed over the life of this Strategy.

3. The new National Carers Strategy

The new National Carers Strategy - Carers at the heart of 21st-century families and communities. "A caring system at your side. A life of your own" - was published by the Government in June 2008.

It builds on the first National Carers Strategy, which was launched in 1999 and takes into account extensive consultation with carers about what is important for them. It also incorporates commitments from the New Deal for Carers.

The new National Carers Strategy states:

'Our vision is that by 2018, carers will be universally recognised and valued as being fundamental to strong families and stable communities. Support will be tailored to meet individuals' needs, enabling carers to maintain a balance between their caring responsibilities and a life outside caring, whilst enabling the person they support to be a full and equal citizen.'

By 2018:

- Carers will be respected as expert care partners and will have access to the integrated and personalised services they need to support them in their caring role
- Carers will be able to have a life of their own alongside their caring role
- Carers will be supported so that they are not forced into financial hardship by their caring role
- Carers will be supported to stay mentally and physically well and treated with dignity
- Children and young people will be protected from inappropriate caring and have the support they need to learn, develop and thrive, to enjoy positive childhoods and to achieve against all the 'Every Child Matters' outcomes

The Strategy also sets out the following priorities for the next 3 years:

- More and better access to information and advice
- New break models and provision
- Expanded NHS services
- Employment and skills flexible working and increased training

- Improving emotional support
- Young Carers protection from inappropriate caring and broader provision of support
- Expert partners in care training for carers
- Workforce training for professionals
- Third Sector support for carers
- Better information about carers

Further priorities from 2011 onwards are then identified. These will be addressed in future Strategies.

4. Carers in Darlington


How many carers are there in Darlington and what do we know about them?

a) Census information

A new question in the 2001 census asked whether each person looked after or gave help or support to family members, friends, neighbours or others, because of long term physical or mental ill health or disability, or problems related to old age. Anything done as part of paid employment was not to be counted.

The responses indicated that there are 5.2 million carers in England and Wales (1:10 of the population), 21% (1.09 million) of whom provide care for 50 or more hours per week.


In England, the North East has the highest proportion of carers (11%) and Durham was the county with the 2nd highest proportion of carers (11.6%).




Information in respect of Darlington shows that there are 10,064 carers, 2330 of whom are providing care for 50 or more hours per week. This is in excess of the previously estimated 8846 carers in Darlington.

Carers in Darlington are found in all wards of the town, although some wards have higher concentrations of carers than others.

The three wards with highest numbers of carers are: Park East (629), Haughton West (551) and Cockerton East (543)




The three wards with the highest percentage of carers are: Hummersknott (13.6%), Hurworth (13.2%) and Park West (13.1%)



The three wards with the highest number of carers providing care in excess of 50 hours per week are:


Park East (187), Cockerton West (175) and Eastbourne (144).




Research undertaken by Carers UK in December 2006 indicates that 65% of people with a caring responsibility did not identify themselves as a carer in the first year of caring and that every year, 37% of the population will have started caring that year and a similar proportion ceased (For Darlington this is 3724 carers).

b). Black and Minority Ethnic Groups (BME)

Census data indicates that the main BME groups in Darlington are as follows:



Of these, the largest groups and the number of carers in each are shown in the graph below. The right hand column in each ethnic group shows the numbers of carers who would be expected in each ethnic group based on census information for the North East. This indicates under representation in each ethnic group in Darlington but particularly in the Bangladeshi and Chinese communities.



Since the census took place, there has been a substantial increase in the number of people from the Polish community living in Darlington (approx 500 registered at the library). Work continues around developing services for all BME groups to ensure that services can be provided in a culturally appropriate way to the benefit of both the carer and the person being cared for.


c). Current information about carers in Darlington

Information about carers in Darlington now comes from a variety of sources including the carers register operated by Darlington Association on Disability (DAD), and activity data in respect of young carers and parent carers.

DAD Carers Register – during the period 1st April, 2007 – 31st March, 2008, 216 new carers came onto the register and 225 left (mainly due to cessation of their caring responsibilities or because they had left the area). This gave a total of 1347 carers who had been on the register during this period.

As of 31st March, 2008, there were 1122 carers on the register a decrease of 9 from the previous year.

Up until this year, there has been a steady increase in the number of carers on the register since it was first introduced in 2001-02. However, this year there has been a very slight decrease.



Young Carers

The 2001 census identified 178 Young Carers aged 15 and under in Darlington. No breakdown is available for those aged 16 and 17 and young carers within this age group will be included in the information about adult carers.

During the year from April 2007 – March 2008, 105 young carers attended YMCA Timeout Young Carers Project. There are currently 80 young carers attending, approximately 1/3 of whom care for a disabled sibling.

Parent Carers

There are an estimated 1540 disabled children and young people in Darlington (Council for Disabled Children), nearly all of whom will have a parent carer. We do not know how many (if any) of the carers identified in the 2001 census were caring for a disabled child.

The Disabled Children's Register (which was a social care database) is currently being replaced by a new database, which will include children known to health, education and social care. The Disability Discrimination Act definition of disability has been used as the baseline criteria. 1446 children's names are on the database, although this may reduce when permission from parents is sought for children to remain on the database.

In November 2008, 126 families (and 143 children) were known to social workers in the Disabled Children's team.

5. Issues affecting carers of specific user groups

a) Mental Health

A National Service Framework (NSF) standard 6 group was set up as a subgroup of the Mental Health Partnership Board to address specific issues in relation to carers of people with mental ill health.

Key issues identified to address were:

- identification and support of carers and family members
- supporting assessments of carers' needs
- issuing care plans
- developing services for carers, including carers groups and forums and establishing a system for consulting carers and involving them in service development and evaluation
- monitoring inclusion of carers from BME communities and young carers
- availability and use of advocacy.

b) Learning Disability

A Carers subgroup of the Learning Disability Partnership Board was set up to address specific issues for carers of people with learning disabilities. So far the group has worked on a Carers Information Pack and a draft emergency plan. The next planned area of work will be to look at the provision of short breaks.

c) Physical and Sensory Impairment

The Physical and Sensory Impairment Board is currently being reviewed. When this is completed, it will give the opportunity to work with carers to identify issues which affect them.

d) Older People and Older People with Mental Health needs

There is a strategy for older people in Darlington and a Strategy and Action Plan for older people with mental health needs is being developed.

e) Parents of Disabled Children

Consultation has recently been undertaken with families whilst developing a Strategy for Disabled Children in Darlington 2008-10. Families identified key areas for development including the following:

- accessible, affordable child-care including: nurseries, childminders, after school clubs and holiday play-schemes that can provide for the needs of disabled children
- user involvement and ongoing consultation that results in real changes and is available to a wide variety of parents, carers, foster carers etc. Representation and consultation on a variety of issues including service development and delivery.
- Parents and carers want information to be made available to them in a number of different ways
- Assessment processes and person-centred planning that is accessible, less bureaucratic and looks at the child and family as a whole and results in services that meet each child's needs as an individual. Better sharing of information between professionals.
- There is a need for better family support (including information exchange) for all members of the family, such as: babysitting, short breaks, holiday provision, befriending, advocacy etc.

f) Young Carers

Young carers are one of the specific areas identified in the new national Carers Strategy. Key areas of concern identified by young carers during consultation on the Strategy were:

- gaps in support for the person they care for
- GPs, hospitals and schools not recognising or taking into account their needs as children and young carers
- gaps in emergency support
- not enough project based support
- importance of joint working between Adult's and Children's services.

Many of these areas are picked up in Darlington's Young Carers Action Plan.

In addition, *the generic equality impact assessment* identified some areas where needs were not being sufficiently addressed, which are picked up in the Implementation Plan. These included lesbian, gay, bisexual and transgender carers.

An area where particular needs were identified were carers (of any service user group) who also have impairments themselves.

6. What Support is available for Carers In Darlington?

At present, support to carers is provided in a variety of ways. These include the following:

- Care Management, Care Co-ordination and Social Work processes within Darlington Borough Council Adult Social Care and Children's Services respectively, which enable the provision of tailored assistance to the person cared for. This includes both the assessment process by which any needs eligible for assistance are identified and the provision of services/support to the person cared for and/or the carer, plus the provision of information and advice
- Specialist Mental Health Carer Support Worker employed by Darlington Borough Council Adult Social Care
- Resources made available to fund a 30 hour per week specialist Learning Disability Carer Support Worker employed by Darlington Borough Council Adult Social Care
- Assistance from health staff in a variety of acute and community settings
- DAD Carers' Support Service funded by both Adult Social Care and Darlington Primary Care Trust (PCT) to provide specific support to carers. This includes the provision of information and advice, one to one support from staff, links to other carers in the area, social activities, relaxation, managing the Carers Register and providing a carers newsletter. The PCT also funds a part time Health Link Worker post to work in GP practices
- Support networks such as the Carers Darlington branch and specific disability organisations such as the MS Society and the Alzheimers Society
- YMCA Timeout Young Carers Project continues the work already commenced to raise the profile of young carers locally and to develop further the provision of breaks services for young carers through group activities and 1:1 support. Awareness raising in schools, both with staff and directly with pupils, also takes place
- Aiming High for Disabled Children has allocated some funding for the development of parent/carers participation in local authorities. Existing support groups e.g. Down Syndrome Support Group together with a further 750 letters of invitation were sent out inviting parent/carers to an information event. At the conclusion of the event it was decided that a bid from DAD,

supported by the local authority would be submitted to help develop a framework for future parent participation.

A Service Development Officer continues to be employed by Darlington Borough Council Adult Social Care to act as a focus for carers' issues within the Borough and to lead on service development.

Short break services are provided by Health, Adult Social Care and Children's Services from a variety of funding sources, including mainstream funding and the Carers Grant (details given below).

Aiming High for Disabled Children funding is also being made available until March 2011 to develop and provide additional short breaks for the parents of disabled children.

An Aiming High for Disabled Children Development Manager has recently been appointed by Darlington Borough Council Children's Services to lead on this agenda.

Those cared-for people receiving breaks funded through Adult Social Care to meet social care needs are financially assessed to determine their contribution towards the services received. Those receiving breaks funded by Health to meet health care needs do not make any contribution towards the cost of their care.

Although breaks services continue to be arranged directly by both Adult Social Care and Children's Services, there has also been an increase in the uptake of direct payments for both short breaks and for direct support to the person cared for. There has also been an ongoing increase in the use of Carer Break Vouchers. This has benefited carers greatly through the provision of increased flexibility and control in how support is received.

Carers Grant

Although Carers Grant funding is no longer ring-fenced by central government, Darlington Borough Council Adult Social Care has continued to retain it for the sole benefit of carers. Funding is spent in several areas including individual breaks (via commissioned services, direct payments or Carer Break Vouchers), Service Level Agreements and development work.

Funding has been allocated as follows and includes 'Help in an Emergency' monies for both Adult Social Care and Children's Services.

No notification has been received regarding funding for 2010 – 11.

7. Darlington's Vision for 2008-11

Our vision is of a future where carers, statutory agencies and the third sector work together to develop services that better support both carers and the people they care for to lead fulfilling lives as equal members of the Darlington community.

This vision is supported by the Implementation Plan attached on pages ??? which identifies six key areas for development which have been agreed by members of the Carers' Strategy Steering Group:

- Better recognition from professionals and inclusion in society
- Information
- Integrated and personalised services
- A life of their own
- Income and employment
- Health and well-being

The first 2 areas were felt to be particularly important in Darlington and the last 4 are taken from the new National Carers Strategy.

The targets set out in the Implementation Plan apply to carers of all service user groups unless otherwise stated.

Young carers' needs are addressed though a separate Young Carers' Action Plan, and the needs of Parent Carers will be addressed through the Parent Carers Action Plan, as identified in the Implementation Plan.

Darlington's existing Sustainable Community, Social Inclusion and Community Engagement Strategies support this vision and will help us to deliver it. Information about each of these strategies is attached as Appendix 2.

8. Monitoring and Review process

Progress against the Implementation Plan actions will be monitored at regular meetings of the Carers' Strategy Steering Group and further actions may be agreed as appropriate.

Progress in relation to the actions for 2007-08 is outlined in the next section.

The Implementation Plan for 2007- 08 covered 5 key areas. Progress in respect of these is as follows:
