Darlington Children's Trust aims to ensure organisations work together, and with children, young people and their families to both identify and address how children and young people can be made happier, healthier, safer, more fulfilled and ready for adult life. A new Children and Young People's Plan (CYPP) has been developed involving our partners and the children and young people in Darlington. The priorities for 2011-2014 have been identified using information from a comprehensive analysis of the needs of children, young people and their families in Darlington and importantly the feedback and comments received from children and young people.

The deletion of this funding within the LA will mean that support for the Children's Trust will cease and that activities such as administrative support at Board meetings, development of reports for the Children's Trust will not be available. This post has also undertaken with LA staff and through partners of the Children's Trust engagement work with children and young people for the Children's Trust co-ordinated through a multi agency Participation group. Whilst the funding for this post is proposed to cease the a multi agency Participation group work programme will continue and will still drive forward key participation and engagement work with all children and young people in Darlington.

There are changes in Darlington being implemented with all partnerships and the Children's Trust is being reviewed as part of this review of the Local Strategic Partnership.
