Further clarification obtained from discussion with the COB member which is not covered within the proposal sheet:

None – the crux of the issue with this proposal is the tie in which is in place through HLF which could result in mothballing liabilities and liabilities costing in the region of $\pounds 1.5$.

The efficiencies which would be achieved as identified on the summary proposal sheet have been identified as £5,000.

The scope of the proposal is potentially large as it could encompass a number of facilities. The focus of the proposal is upon preservation of the resource/s. Therefore it is envisaged that resources should not be lost through this proposal.

The proposal assumes that the existing service levels will be maintained.

The EIA duties of the authority will be passed onto any Trust through formal contractual requirements.

There will be a focus on the proposal upon governance issues, there will two council officers on any governance structure devised through the cultural trust.
