WOMEN INTO ENTERPRISE PROJECT

Purpose of Report

1. To seek Cabinet approval to extend the Women Into Enterprise Project with Council funding for a further year and to enter into a new Service Level Agreement with Darlington Business Venture for the delivery of the project.

Information and Analysis

Background

- 2. The Women Into Enterprise Project was established in September 2001 and was part funded through the European Social Fund until March 2004. The Project was extremely successful with over 50 women being assisted to establish their own business and with over a 100 members in the Network.
- 3. The aim of the project was to raise the awareness of women's capacity to start and manage effective businesses and to provide mentors and 'how to' information to enable them to do so. It also assisted in breaking down the barriers, which stood in the way of women's success in business factors such as lack of confidence, opportunities, advice and support. The project was delivered by Darlington Business Venture, under a Service Level Agreement with the Council.
- 4. An application was submitted under Objective 3 for European Social Fund assistance to extend the project for a further period. However, there were insufficient funds remaining in this Programme to satisfy all the applications received and the application could not, therefore, be supported.

Extension of the Project

5. Darlington Business Venture will encourage the establishment of women-run businesses and offer pre-start advice and counselling services, which are additional to the mainstream activity available through Darlington Business Venture's Business Start programme. They will provide training sessions at different levels to suit the various needs of the Darlington Women's Business Network membership, covering both business and personal skills. 6. Darlington Business Venture will co-ordinate the Darlington Women's Business Network, building on the existing network membership base. A newsletter will be produced on a bimonthly basis and a directory of the membership will be developed. They will continue to develop the Women's Mentoring Programme, by encouraging existing members to mentor new members. This will also enable the existing members to continue with their personal development and to build their confidence through providing support to others.

Summary

10. The Project provides a valuable service and much needed support to women entrepreneurs in Darlington, thereby supporting National and Regional enterprise objectives. Darlington Business Venture has a long-standing reputation for supporting business start-ups and they have been awarded the contract to operate the Business Link Business Start Up programme in Darlington.

Outcome of Consultation

11. The Women Into Enterprise Project is supported by Darlington's Community Strategy, One NorthEast's Regional Economic Strategy and by Business Link's Corporate Strategy.

Legal Implications

12. This report has been considered by the Borough Solicitor for legal implications in accordance with the Council's approved procedures. There are no issues which the Borough Solicitor considers need to be brought to the specific attention of Members, other than those highlighted in the report.
