#### FINANCIAL ASSISTANCE 2004/05

#### **Purpose of Report**

1. To consider eleven applications in respect of financial assistance received from nine charitable and non-profit making organisations and two individuals, details of which are contained in the report.

# **Background**

2. The total committed in respect of applications made in the current year is £4,434. The Council has made provision within the 2004/2005 revenue budget of £15,000. This leaves a balance of £10,566, and is before consideration of the attached applications.

# 3. **Darlington Credit Unions**

#### (a) Introduction

An application has been received from the one of the four Darlington Credit Unions for financial assistance of £300 towards their administration costs.

A Credit Union is a non profit making co-operative society offering its members loans out of a loans pool of savings built up by the members themselves. It is owned, operated and controlled by a group of people who have a common intent. A borrower's credit rating is not assessed on the basis of wealth and status, but on proven ability to save. By agreeing to save regularly, members build up a fund from which they can borrow at favourable interest rates. This interest should provide the union with revenue to cover administration expenses. Any surplus is returned to the members in the form of dividends on savings.

The Darlington Unions are part of the Darlington Credit Union Forum who meet every six weeks to discuss problems and ways of solving them. The Forum consists of the four Darlington Credit Unions and one each from Aycliffe, Colburn and Shildon.

Each union must be affiliated to one of the two National organisations :-

ABCUL - Association of British Credit Unions

NFCU - National Federation of Credit Unions

The memberships of all credit unions vary according to the size of the area to which credit unions serve.

# (i) Firthmoor, Eastbourne and Lascelles

# 4. Darlington and District Dyslexia Support Group

#### (a) Introduction

An application has been received from the Treasurer of the Darlington and District Dyslexia Support Group for financial assistance towards the work of the group and to include the continuation of a newly established touch type read and spell computer course based at Morton Park for its members. In addition, financial assistance is sought to assist with the cost of providing guest speakers to attend meetings.

Darlington and District Dyslexia Support Group is a registered charity, is affiliated to the British Dyslexia Association and is also funded entirely from charitable donations. Membership fees are £10 per person which comprises an annual fee to the British Dyslexia Association of £4.50, a BDA handbook £4.00, Postage and stationery £1.50. The Group does not operate for a profit. At the present time the current membership totals 35.

The Group holds informal monthly meetings in order to meet other dyslexics, to exchange ideas and experiences and primarily to raise the awareness of dyslexia in and around Darlington. Guest speakers are invited to attend these functions which enable members and carers to ask relevant questions on coping with Dyslexia.

# 5. Darlington Charity Partnership – Payroll Giving Consortium, (Comprising Darlington Age Concern, Darlington MIND, Darlington Samaritans, Friends of Darlington Memorial Hospital and St. Teresa's Hospice, Darlington)

#### (a) Introduction

A letter of application has been received from the Corporate Fundraising Manager based at St. Teresa's Hospice on behalf of the Darlington Charity Partnership for financial assistance of £2,563.10. This is specifically towards the setting up costs for a new initiative which hopes to generate income from payroll giving support from both local companies and their employees.

The Darlington Charity Partnership (DCP) is a consortium of five charities based in Darlington, mentioned above, and have submitted a proposal to raise on-going funds for their work in the Darlington Community. It is anticipated that once the project is up and running any future costs will be met from funds raised and it is their aim to raise at least £2,000 for each charity involved within a year of launching the scheme.

It is the Partnerships intention to generate at least £10,000 per annum within a year of the launch date, this can be achieved by generating an average of 200 donors giving £50 per annum, also via promotions to at least five companies with an average of 200 employees (looking to generate a 20% response) and by making approaches to 15-20 companies during the initial test period.

# (b) Financial Information

All of the member charities have freely committed their time and there will be no salary costs for the initial project as volunteers from each organisation have shared the workload. The initial costs are concerned with the design and printing of the materials needed to run a successful campaign and are highlighted in the table below.

#### (a) Introduction

Applications have been received from various Youth and Community Associations, (see list below) for financial assistance towards the cost of proposed playschemes to be held during the summer holidays.

#### 7. Council Policy

(a) A report was considered by Members in June 1992 in which the outcome of consultations with the organisers of playschemes was outlined. It was resolved that a system of index-linked grants be introduced from 1st April, 1992, with additional amounts for newly established playschemes in the first year and special needs playschemes each year.

If Members were to follow this guideline the grant would need to be increased from £770 to £785, an increase of 2%, this being the rate of inflation at January 2004 in respect of schemes (i) to (vi) above.

#### (b) Conclusion

The Cabinet is asked to consider a grant of £785 towards the running of each of the six playschemes listed above, a total of £4,710.

# 8. Eve Lucy Doherty – Raleigh International, Costa Rica and Nicaragua Expedition, January 2005

#### (a) Introduction

An application has been received from Eve Doherty who resides in Darlington. Eve is seeking financial assistance as a contribution towards expenses incurred whilst undertaking her expedition to Costa Rica and Nicaragua with Raleigh International,

scheduled to take place in January 2005.

The total cost of the trip is anticipated to be in the region of £3,500 in total and Eve has managed to raise part of her target through on-going fund raising activities. Raleigh International is a leading youth development charity that offers 17-25 year olds from all over the world the chance to visit one of five expedition countries to take part in environmental, community and adventure projects which encourages young people to learn new skills in leadership, communication, organisation and motivation.

# (b) Financial Information

The total cost of the trip is anticipated to be in the region of £3,500 and Eve has managed to raise £740 through the following fundraising activities.

# 9. Paul Holloway – Attendance at Heidelberg University, Ohio, Professional Football Scholarship, Scheduled to take place in August 2004

#### (a) Introduction

An application has been received from Paul Holloway for financial assistance of between £1,500-£2,000 towards the costs of flights, tuition fees and accommodation from August 2004 to January 2005 in order that he can study in America.

Paul who is 19 years old and resides in Darlington has been offered a 4 year football scholarship at Heidelberg College, in Ohio where he hopes to obtain a degree in sports and business. Paul has played for Crook Town in the Northern League and attended Longfield School before studying for a Btec in sports performance and excellence at Darlington Football Academy.

# (b) Financial Information

The total cost Paul needs to raise in order to take up the chance of studying in America is anticipated to be in the region of £3,500. This amount takes into account flight costs, tuition and living expenses from August 2004 to January 2005 only, as the remaining funding has already been secured from an American Company .

He has been successful in obtaining funding from some local businesses which at the present time amounts to £1,400. Paul is currently working on a full time basis during the day and has also secured a second job to help meet these expenses.
