SOUTH PARK CARPET BED

Purpose of Report

1. To consider applications for the design of the South Park Carpet Bed.

Background

- 2. The Carpet Bed in South Park is open to community groups for planting displays to promote their organisation. This year two requests have been received from:
 - (a) Darlington Operatic Society
 - (b) Darlington Rotary Club
- 3. Details of the applications are as follows:

(a) Darlington Operatic Society

Darlington Operatic Society was reformed after the War in 1945. They have produced musical shows in what used to be the Hippodrome, now Darlington Civic Theatre, since that time. Membership is drawn from all walks of life and through their endeavours they have donated approximately £8,000 to St Teresa's Hospice last year. Other local charities have also benefited.

This year, the Society are commemorating their Diamond Jubilee and have requested a planted design in South Park Carpet Bed.

(b) Darlington Rotary Club

The Rotary Club is celebrating the organisation's Centennial year. The organisation has donated to various local charities and projects, including St Teresa's Hospice, Abbeyfield Retirement Home and the new Training Centre for Visually Impaired People at the Arts Centre.

As part of their Centennial year celebrations, the Rotary Club have requested a planted design in South Park Carpet Bed.

Outcome of Consultation

4. No consultation has taken place.

Legal Implications
