#### FINANCIAL ASSISTANCE 2004/05

# **Purpose of Report**

 To consider four applications in respect of financial assistance received from one charitable and non-profit making organisation and three individuals, details of which are contained in the report.

#### **Background**

- 2. The total committed in respect of applications made in the current year is £13,757.10. The Council has made provision within the 2004/2005 revenue budget of £15,000. This leaves a balance of £1,242.90 and is before consideration of the attached applications.
- 3. Tempest Social Club, Tempest Anderson House, Brinkburn Road, Darlington.
  - (a) Introduction

An application has been received from the Treasurer of the Tempest Social Club for financial assistance of £150 towards the provision of summer outings and Christmas/New Year activities for its members who are pensioners.

At the present time there is a membership of 50 who each pay a subscription of 30 pence per week for the provision of tea and biscuits. The club meets on a weekly basis at the Tempest Anderson House for social activities such as bingo and dominoes, exercise classes, coffee mornings, fish and chip nights and during the year various trips are organised which include Christmas and New Year activities for its members.

# 4. Andrew Finn – Invitation to Represent England at the Under 14's Ice Hockey Championships in Windsor, Canada – December 2004

#### (a) Introduction

An application has been received from the mother of Andrew Finn for financial assistance of an unspecified amount towards the costs of attending the under 14's Ice Hockey Championships to be held in Windsor, Canada in December 2004.

Andrew who is 13 years old and resides in Darlington currently plays ice hockey for Billingham Bombers under 14 team. The Championships take place in December 2004 with the team spending two weeks in Canada and whilst they are there they are required to play 10 to 12 games. Training sessions are scheduled on a monthly basis in Nottingham.

# (b) Financial Information

In order that Andrew can compete in these events he needs to raise in the region of £735. The specific purpose of this application is to assist with the attendance of this Championship and does not include for training expenses, accommodation and subsistence costs. A brief summary of anticipated costs has been obtained and is detailed in the following table:-

# 5. Ellie Martin – World Challenge Expeditions, Tanzania – November 2004

#### (a) Introduction

An application has been received from Ellie Martin, an 18 year old student who resides in Darlington. She is seeking financial assistance as a contribution towards expenses incurred whilst undertaking her expedition during her gap year to Tanzania with World Challenge Expeditions, where she will teach English to primary school children. This expedition is scheduled to take place in November 2004.

World Challenge Expeditions specialise in the provision of leadership, teamwork and personal development training for young people. This organisation works with schools, colleges, central government, individuals and youth groups to ensure that every young person is encouraged to have a wide range of skills, development and educational opportunities.

#### (b) Financial Information

The total cost of the trip is anticipated to be in the region of £2,395 and Ellie has managed to raise £1,370 through the following fundraising activities.

# 6. Miss Alice Woods – Invitation to Attend the National Children's Under 14 Orchestra - Residential Courses, (NCO) at Ackworth School, Pontefract and Dorset.

#### (a) Introduction

An application has been received from the Alice's parents for financial assistance amounting to £600 towards the cost of attending three residential courses held throughout 2005.

Alice who resides in Darlington is 13 years old has been invited to attend the under 14 Orchestra playing the flute and piccolo. The National Children's Orchestra has been established since 1978 and exists for talented children under the age of 14. These courses provide music tutors from major orchestras, conservatoires and specialist music schools for the benefit of these students.

#### (b) Financial Information

The cost of the under 13 full symphony orchestra residential courses both at Pontefract and Dorset amounts to £890. The specific purpose of this application, amounting to £600 is to assist with the attendance fees and does not include travel expenses, the purchase of instruments or local tuition fees

#### (c) Previous Applications

Alice Woods has applied and been granted £300 financial assistance on one previous occasion in order that she could to attend the National Childrens Orchestra Residential Course at Ackworth School throughout 2004. Cabinet C130/November/2003 refers.
