SOUTH PARK CARPET BED

Purpose of Report

1. To consider applications for the design of the South Park Carpet Bed.

Information and Analysis

- 2. The carpet bed in South Park is open to community groups for planting displays to promote their organisation. This year, one request has been received from:
 - (a) The Boys' Brigade
- 3. Details of the application are as follows:
 - (a) The Boys' Brigade

The Darlington & District Battalion of the Boys' Brigade recently celebrated its 50th Anniversary and the Boy's Brigade nationally is 125 years old in 2008. The Darlington & District Battalion has four companies with in excess of 120 boys taking part:

- (i) 1st Darlington at Willow Road Community Centre
- (ii) 2nd Darlington at Northlands Methodist Church
- (iii) 5th Darlington at Cockerton Methodist Church
- (iv) 1st Newton Aycliffe at Neville Parade Methodist Church

The Boys' Brigade is a Christian Uniformed Youth Organisation catering for boys between the ages of 5 years and 19 years, working towards badges through a structured scheme. Some of the activities involved include sports, life skills, activity weekends, developing planning, organisational and leadership skills and a general knowledge of the Christian Faith. The aim of the Boys' Brigade is to equip boys with good moral values and the ability to go out into the world with confidence.

The Boys' Brigade would like the carpet bed design to reflect their logo. A copy is attached as **Appendix 1**.
