REQUEST TO RELEASE CAPITAL FUNDING FROM THE MEDIUM TERM FINANCIAL PLAN – AIR CONDITIONING INSTALLATION FOR CUSTOMER SERVICES/HOUSING BENEFITS

Purpose of the Report

1. To request the release of funding within the capital programme to install an air conditioning system within the Customer Services Centre, Interview Rooms and Room G.O.2 (Housing Benefits) on the Ground Floor of the Town Hall.

Summary

2. This report requests release of capital programme funding to install an air conditioning system in the Customer Services/Housing Benefits areas on the Ground Floor of the Town Hall to alleviate the extreme high temperatures experienced during the Summer months by members of the public and employees in these areas.

Recommendation

3. It is recommended that £35,000 be released from the Council's Capital Programme to install the air conditioning system.

Reason

4. The recommendation is supported to ensue that the environmental conditions in the Customer Services/Housing Benefits areas are reasonable.

Information and Analysis

- 5. This report requests the release of funding within the capital programme to install an air conditioning system within the Customer Services Centre, Interview Rooms and Room G.O.2 (Housing Benefits) on the Ground Floor of the Town Hall.
- 6. The Council has committed £35,000 in the capital medium term financial plan for this Scheme.
- 7. For some time employees working in these areas have complained about the extreme temperatures experienced over the Summer months. Temperatures have been found to be in the 30 degrees centigrade range making working conditions uncomfortable to employees but also making the environment very uncomfortable for the public using the Customer Services Centre and the interview rooms in the Centre.
- 8. The Customer Services Centre and the Housing Benefits Room have floor to ceiling glass windows and consideration has been given to an alternative scheme of applying a solar reflective film to the external windows to reduce the sun's glare. However due to the volume of the glazed area it is considered that the reduction in temperature will be minimal with this course of action and a scheme for the installation of an air conditioning refrigeration system has been developed.

Scheme

- 9. The total cost of the Scheme is £34,955.05 and a breakdown is attached at **Appendix 1.** A plan showing the areas within the Customer Services Centre and the Housing Benefits Office and the installation of the Units is attached at **Appendix 2.**
- 10. The scheme involves the removal of two 9 KW wall mounted heating units which will offset the environmental impact of the Air Conditioning Units.
