#### COUNCIL CAPITAL PROGRAMME – RELEASE OF FUNDS

## **Purpose of Report**

1. To seek approval for the release of grant funding for the Mobile Board, Biking and Blading Unit –The Truck.

# **Information and Analysis**

- The Leisure and Arts Service Plan for 2003/04 included a commitment to research solutions
  with young people for the provision of a skateboarding, biking and blading facility in
  Darlington.
- 3. Early work involved a Steering Group of young people successfully accessing a £15,000 Princes Trust grant to research the solution in more detail. The young people also supported the Council in making an application to the New Opportunities Fund for £70,000 to fund a Mobile Boarding, Biking and Blading facility. The application was successful and funding has now been received.
- 4. This funding covers the initial capital cost to purchase the chassis, demountable body unit and mobile equipment for the facility. Revenue funding for the project has been included in the Leisure and Arts MTFP as part of normal outreach budgets, with targets set for seeking external partnership funding and sponsorship to enable further projects to be developed.
- 5. The deadline for implementing the project is August 2004 and preliminary works have been carried out in order to ensure compliance with guidance from advisory organisations.

### **Outcome of Consultation**

6. Prior to the application for funding being made, extensive consultation was undertaken with young people to find out the type of equipment they would prefer and facilities. The outcome of this consultation was built into the submission for funding.

## **Legal Implications**

7. This report has been considered by the Borough Solicitor for legal implications in accordance with the Council's approved procedures. There are no issues which the Borough Solicitor considers need to be brought to the specific attention of Members, other than those highlighted in the report.
