## SINGLE REGENERATION BUDGET 2004/05

## **Purpose of Report**

1. The purpose of this report is to request the release of capital funds secured from the Single Regeneration Budget (SRB) for 2004/05, other external contributions and the Council's contribution to these projects.

#### **Information and Analysis**

- 2. The six-year Darlington Community Works regeneration programme began in April 2000, funded by a grant of £4,565,555 from the Single Regeneration Budget (SRB). The overall programme includes the regeneration of Firthmoor estate as well as a number of town wide economic development projects.
- 3. As Accountable Body for the Darlington Community Works, Darlington Borough Council are responsible for assessing and appraising the individual projects which make up the programme, prior to their approval through various partnership mechanisms.

# Capital Projects Scheduled for 2004/05

- 4. As part of the programme a number of capital projects are due to be undertaken in this financial year.
  - (a) *Traffic Management* (£23,000)

Construction of traffic calming measures at Holgate Moor Green and Emley Moor Road in Firthmoor, to reduce vehicular speeds and reduce traffic accidents.

(b) *Learning Intranet* (£25,250)

Installation of cyber kiosks in targeted areas of Darlington including the Town Centre, the Railway Station and Morton Park to provide access to learning opportunities and resources via a Darlington intranet.

(c) *Town Centre Initiative Phase 2 (£33,500)* 

Small scale physical improvements in Bondgate to streamline street furniture provision

and facilitate a more attractive pavement café area.

(d) Doorstep Greens (£233,321)

The creation of a 'Doorstep Green' at Holgate Moor Green in Firthmoor, which is a communal green area, designed by the community, for the community.

(e) *Environmental Action (£18,500)* 

Funding reserved for environmental improvement projects in Firthmoor. Details of specific project activity are yet to be confirmed, but members will be informed as part of the budget monitoring process.

# Funding Contributions

- 5. As with all major regeneration schemes in Darlington, the Council are a key partner and will deliver the majority of the activity across these projects. A large proportion of the match funding for the programme will also be secured through Darlington Borough Council, which will mean the majority of the funding for projects will at some stage pass through the Council's financial system. This includes the following contributions from external bodies:
  - (a) Traffic Management: £11,500 (Local Transport Plan)
  - (b) Learning Intranet: £3,750 (Darlington's education providers)
  - (c) Town Centre Initiative Phase 2: £10,000 (private sector contribution towards a small grants scheme)
  - (d) Doorstep Greens: £208,571 (St Martins Care Homes £12,000, Countryside Agency £43,450, European Regional Development Fund £111,864, Living Spaces £41,257)
- 6. Alongside the externally secured match funding, these projects also contain a direct funding contribution from Council budgets, which comprises:
  - (a) Learning Intranet: £3,750 (management, staff training, advisor time, Corporate Services Department)
- 7. This money is programmed into existing Council budgets and does not represent a request for further resources.
- 8. In summary, total SRB allocations, Council and other contributions for 2004/05 are as follows:

13. For the purpose of the 'call-in' procedure this does not represent an urgent matter

# Recommendation

14. It is recommended that the funding for 2004/05 as detailed in the above table be released subject to final external funding approvals being given by the funding bodies.

- 15. The recommendations are supported by the following reasons :-
  - (a) To enable the projects to proceed.
  - (b) To enable the council to maximise the amount of external funding available to the Borough.
