**CYP30. DECLARATION OF INTERESTS** – There were no declarations of interest reported at the meeting.

CYP31. PROGRESS ON THE DARLINGTON KEYSTAGE 2 TO 3 SCHOOLS TRANSITION PROGRAMME – The Director of Children's Services submitted a report (previously circulated) to outline existing provision and planning developments for school pupil transition from Key Stage 2 to 3.

In Summer 2008, 11 Transition Action Groups (TAG) were initiated in order to improve the transition experiences for pupils in Darlington moving from their primary to secondary schools and the submitted report gave details of the progress made to date by the Action Groups and outlining the next steps for transition development.

The Director of Children's Services and the Assistant Director (School Improvement and Development) undertook an exercise with the pupils to gauge their worries in relation to the transition form Key Stage 2 to 3 and the things that they were looking forward to. It was established that the young peoples main worries were getting lost in their new schools and most were looking forward to meeting new people. The views of the pupils will be fed into the next Transition Conference.

**RESOLVED** – That the report and views of the young people be noted.

**CYP32. ROAD SAFETY** – The Director of Community Services submitted a report (previously circulated) to inform Members of the actions that the Council carry out in order to

improve the standard of road safety, with particular reference to pedestrian training activities for Primary aged children.

The submitted report provided and overview of the efforts made by this authority to reduce road traffic casualties, what measures are undertaken, the pedestrian training initiatives and sought the views of the young persons thereon.

**CYP33. PLAY STRATEGY** – The Director of Children's Services submitted a report (previously circulated) to update Members of the work taking place to improve opportunities for Play in Darlington.

Officers were seeking the views of the pupils on how they would like to see the £1,128.558, which has been made available to Darlington over 2 years 2009/10 and 2010/11 to develop 22 play areas, being spent. This money will also include the refurbishment of existing sites.

It was reported that consultation with children, families and local communities has been very extensive and very specific to local areas and as part of the contract with Groundwork, consultation is the starting point for each individual project.
