## OUTCOME OF LEGAL PROCEEDINGS 01 SEPTEMBER 2011 TO 31 OCTOBER 2012

### **Purpose of Report**

1. To advise Members of the outcome of legal proceedings in relation to licensing matters.

#### **Information and Analysis**

- 2. The schedule attached to this report at Appendix 1 gives details of proceedings taken against individuals in relation to various licensing offences. This has resulted in £966 fines and £637.50 costs being levied at the Magistrates Courts. In addition 2 cautions have been issued to individuals in respect of taxi licensing offences.
- 3. The schedule attached to this report at Appendix 2 gives details of an appeal by an individual driver against the decision of the Licensing Committee to revoke his licence. This appeal did not succeed and £1130 costs were requested by the Council however no costs were awarded because the appeal had resulted in the driver losing his employment.

## **Legal Implications**

4. There are no issues that the Borough Solicitor considers need to be brought to the specific attention of Members, other than those highlighted in the reports.

5. The contents of this report have been considered in the context of the requirements placed on the Council by Section 17 of the Crime and Disorder Act 1998, namely, the duty on the Council to exercise its functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.
