### ANNUAL ASSESSMENT OF DARLINGTON CHILDREN'S SERVICES

### SUMMARY REPORT

### **Purpose of the Report**

1. To inform Children and Young People's Scrutiny of the outcome of the annual assessment of Children's Services in 2010 by Ofsted.

#### **Summary**

- 2. Each year, under section 138 of the Education and Inspections Act 2006, Ofsted publish a summary of inspection judgements carried out in the preceding 12 months in each local authority area and provide a letter summarising the inspection judgements and other related data.
- 3. The list of inspected services includes those managed by the local authority and those run by private, voluntary and independent providers. The inspected services include education settings, childcare and arrangements for looked after children.
- 4. The Ofsted judgement of services provided within the local authority area was that the services were performing adequately. The text of the letter then notes that 'national performance measures show the very large majority of outcomes are in line with or above the averages for England or for similar areas' and that 'outcomes for children and young people are improving in Darlington'. Services for looked after children were graded as 'good' overall and services for safeguarding children were also graded as 'good' overall.
- 5. Ofsted grade each block of inspected services either as outstanding, good, satisfactory or inadequate. The Ofsted grades for Darlington local authority services for each block in 2009 and 2010 are set out, below:

6. Other services graded by Ofsted, and which contribute to the overall judgement of the local authority, include childminders, non-domestic childcare, St Aidan's Academy, Darlington

College, Queen Elizabeth Sixth Form, private children's homes, private fostering and adoption.

## Recommendations

- 7. It is recommended that the Children and Young People Scrutiny Committee:-
  - (a) consider the Annual Assessment Letter for 2010
  - (b) note that Tim Loughton, the Minister of State, has written to Ofsted to inform them that he is bringing forward legislation to end the annual assessment of children's services because 'it adds little to the understanding of children's services in an area over and above the individual inspections which underlie it'. A further annual assessment may be made depending on the timing of any legislative changes.
