The proposal is that the Civic Theatre is to be sold as a going concern and will continue to deliver a theatre programme without the need for subsidy from the Council.

The content of this impact assessment is based on potential impacts if the Theatre does not deliver a comparable service following the sale. It is based on the current offer and highlights those likely to be impacted on if the offer changes. This is an initial impact assessment only and will be revisited and refined as the future of the Civic Theatre becomes clearer.
