Supported Bus Services	Officer provided an overview of the proposal. Resident lives in Stillington but attends Darlington College – removing the bus service would make it extreamly difficult to continue to attend college. Only alternative option would be a bus to Stockton (No. 7) and then another bus to Darlington (No. x66). Arrival would be later and the cost would increase. Bus drivers are stating that the route will be stopped very soon. Officer explained that a number of options were being explored (reduced key times service, smaller bus/taxi service, car sharing with other students or residents). Further consultation will be undertaken in May and June with Cabinet making a final decision in July. No changes will be implemented until October 2011 at the earliest. Resident accepted that the service may not run often but would be happy to come into town early as long as a service continued which enabled him to attend college. Resident would have real trouble attending the Doctors Surgery in Stillington if the bus service was cancelled. Tried to register at a Doctors surgery in Darlington but unwilling to accept them as a patient as they live too far from town. Willing to use the walk-in centre but this is not suitable for medium to long term medical conditions. Resident realises that the public don't use the bus services as much as they should but there are residents that do need a service, even if it is limited to morning, lunchtime and evening. Happy to be flexible to retain a minimal service. Main criteria is a bus that gets to Darlington before 9am so that daughter can attend college on time. Don't mind if it is only a skeleton service (8am, 1pm and 5pm). Officer explained that the owner of the current bus service has also been asked to put forward suggestions and recommendations as to how the savings could be made with a reduced service. May need to consider using small buses (taxis) for reduced number of passengers. The resident confirmed this would be acceptable as long as the costs remained reasonable.
Supported Bus Services	Officer also explained that Durham are consulting on reducing their bus services which currently operate within Darlington – not clear what implication this may have on other routes in Darlington which would also need to be taken into consideration. Officer suggested that residents may want to consider car-sharing or organising lifts. This could be arranged by the Council, the College (for students) or by local community groups. Resident explained that there isn't a community spirit in the villages as there are lots of big houses with big gates who you never see. Big divide between the classes in villages and removing public transport would make the situation worse as families who can't afford a car will have to move away from village life and back into the town centres. Really don't want to have to leave their home just because of the buses. Feel that the money is available to the Council it just isn't being spent in the right places – need to make sure that Members listen to the public.

Supported Bus Services	Officer asked if the resident would consider cycling. Resident explained that cycling had been tried before but the country roads are quite dangerous and the weather makes it very difficult to travel at some times (can't rely on cycling). The resident explained that they would be willing to consider all options for accessing shops etc, but the most important concerns are travel to college and access to a Doctors surgery. Could Arriva consider combining a service that operates between Stockton and Darlington and picks up in the villages? The resident will encourage other residents to respond to the consultation and express their need for a bus service.
Bus Services - Young People	Comment- transport for young people already expensive. Teen card only for off peak travel. Cost of travelling to college can be expensive. If EMA withdrawn some YP may not be able to afford cost of travel to college
Early Years Inclusion	Can Schools look to their own budgets to keep this service going in the early year's provision?
Early Years Inclusion	Concerns were raised about the impact for removing the support at early years will reduce the amount of children accessing mainstream education
Early Years Inclusion	Concerns were raised about the cut in funding and how since meeting with Murray in November still no response
Early Years Inclusion	Concerns raised at how more support will be need later in the Childs life and this wont make any savings
Early Years Inclusion	Concerns over the lack of Staff consultation with the Early Year's team they feel that if they were asked to work differently to make savings they would of to reduce the risk of redundancy.

Early Years Inclusion Cuts to Services for Disabled Children/LEA residual functions	Issue – Parents of child with visual impairment concerned about impact of cuts on services for their child. * Officers responded to this issue and issue below explaining that the money saved from staffing reductions would be used to commission alternative provision which would be more widely available and not just available in limited settings. The proposal is to use specialist staff to provide training to non specialist staff in settings where there is a child with special needs to enable parents/carers to be able to send their child to a setting of their choice. There is a duty to teach all children and currently not all settings are able to provide specialist provision. The council is aiming to improves service through this change in the way in which the service will be delivered and give parents/carers more choice.
Early Years Inclusion Support for Disabled Children and Young People	The above Issue led on to discussions with YP from DAD young leaders about requirement for specialist provision in schools and need for statements of SEN Response – explained that money now pushed down to schools to deliver provision through School Action and School Action + although some SEN statements still made where appropriate. Discussion took place around the need for early intervention and provision of integrated services. YP wanted to be assured of council's commitment to maintaining disabled children within mainstream provision where possible.

Initiatives to reduce/prevent ASB seem to be being cut. Young people felt they were suffering because of unacceptable behaviour of a minority, this should not affect service provision Response – Had YP considered alternative provisions such as Scouts, Guides and youth services provided by faith groups? The majority of YP said no, although one YP said they went to 2 different church groups at different venues which were run by the churches on church premise, but had no faith basis were just run as youth groups. Other members of the group did not seem keen to consider these alternative options Councillor Hughes suggested that perhaps young people should consider setting up alternatives themselves, that the council needs to be able to empower young people. This was generally thought to be a good idea by the YP

Concern re lack of money for youth clubs and impact of staff losses on ability of local authority to be able to continue to run youth clubs. Response – looking at alternative ways to provide youth service provision. Some of the venues currently used for youth groups require capital investment and money not available for necessary maintenance/repairs. Local authority looking at possibility of asset transfer. Further comment made by young people that they felt private sector inappropriate to fund the areas which may be cut. They can work faster and more efficiently by picking up bin bags only. Officer explained that black bags are provided by householders themselves and involve a cost – not everyone can afford strong black bags. As long as the rubbish is tied up in bags, it is good for the collection service
Street Scene	Encourage local residents to do more things themselves eg. cut verges outside their houses Ask local residents to get involved in their neighbourhoods eg. through Community Partnerships with local litter picks with young and older people working together to improve their areas, cutting verges, planting flowers etc – this could be part of 'The Big Society' idea
Street Scene	Are DBC maintaining footpaths any more? How is money being saved in street scene when they don't seem to have any capacity to save any more and do a good job? Are the country side staff team being reduced?
Street Scene	Adults who are fined for littering or fly tipping offences should have to pay back with community service sessions as well as paying their fines, as this might be a deterrent to future littering. It would also encourage people to look after their areas more. Officer explained that young people are doing some of this already but adults don't pay back in this way at the moment. His department is now linked to the Restorative Justice system to offer community payback work that benefits local communities
Street Scene	Sharps boxes to be installed in local parks & neighbourhood areas. This could be a possible way to support the safe removal of drug related waste/equipment that is found in neighbourhood areas. Cllr Hughes has raised this issue in the past but thinks it should be visited again as there is an ongoing problem with needles in many local parks.
Street Scene	Advertise youth consultation events in all local schools via assemblies & notice boards not just through the school councils. Both young people on this table had heard about the event through their involvement with the Youth Service but didn't feel it hadn't been widely advertised through their school (Carmel). They suggested announcing events via school assemblies, class announcements and notice boards. Ask young people themselves how to organise and run the best events for young people!!
