Purpose of Report

1. To report the Public Protection and Community Partnerships Scrutiny Committee's recommendations in relation to the Dog Warden Service.

Information and Analysis

- 2. The Public Protection and Community Partnerships Scrutiny Committee at its meeting on 4th January, 2005 established a Review Group to investigate how the Dog Warden Service operates and the associated problems of dog fouling and noise nuisance.
- 3. The detailed findings of the Group are outlined in the attached report (Appendix 1).
- 4. The Public Protection and Community Partnerships Scrutiny Committee at its meeting on 6th December, 2005, accepted and endorsed the recommendations of the Review Group and agreed to forward the following recommendations to Cabinet :-
 - (a) That officers continue to develop issues identified including promotion, having particular regard to the contact number and naming and shaming following issue of fixed penalty notice.
 - (b) That the Street Scene Review Team examine the proposal to develop an Environmental Enforcement Crime Team to include the Dog Wardens and to provide a much increased focus on dog fouling enforcement.
 - (c) That regardless of whether the Environmental Enforcement Crime Team is set up, officers secure enhanced priority for enforcement of dog fouling legislation.
 - (d) That officers pursue the issue of local kennelling in preparation for the loss of the police facility.
 - (e) That a local indicator be developed to demonstrate and measure the level of attention to fouling enforcement.

Director's Comments

- 5. The recommendations of the Review Group identify several relevant issues which can be progressed, partly through the Street Scene Review and partly through the proposed development of the Environmental Crime Team within Community Services.
- 6. The kennelling issue is being explored on both a local basis and at a regional level within our Tees Valley partners.

Outcome of Consultation

7. In undertaking this Review the Group consulted various people which included Darlington Borough Council's staff, third party potential providers and other Local Authority Providers and their comments were taken into consideration when compiling the final report.

Legal Implications

8. This report has been considered by the Borough Solicitor for legal implications in accordance with the Council's approved procedures. There are no issues which the Borough Solicitor considers need to be brought to the specific attention of Members, other than those highlighted in the report.
