SUMMARY REPORT

Purpose of the Report

1. To report the final findings of the Provision of Culture Review Group undertaken by Place Scrutiny Committee to understand the issues around provision of culture for Darlington and to identify potential solutions.

Summary

- 2. At a meeting of the former Economy and Environment Scrutiny Committee held on 8 September 2011 it was agreed to establish an Arts Task and Finish Review Group which was subsequently re-named Cultural Provision Review Group. Terms of Reference were developed and approved by Place Scrutiny Committee and all Members of that Committee were invited to participate in the Review.
- 3. The Review Group has met on eight occasions and a wide number of issues have been discussed and considered at those meetings.
- 4. At its meeting held on 3 September 2014 Place Scrutiny Committee approved the following recommendations for submission to Cabinet.
