## **Appendix 8----The Provision of Arts venues**

We support this report

Darlington is high on the UK list of the provision of Arts and consolidation in the Arts Centre has contributed to this achievement.

We consider any loss of Arts provision in Darlington would be an unacceptable loss to the town's future economic development.

#### The Arts Centre

In respect of the Arts Centre this has widespread use and support and contains all the elements of good arts provision.

We acknowledge that the costs of maintaining a large, elderly building poses a real financial risk, but fear that dispersal of its current activities risks decline and atrophy of valued artistic endeavour.

Should the majority group choose to close the Arts Centre, all proceeds from its disposal should be ring –fenced to provide a replacement central facility delivered as quickly and cost-effectively as possible.

As previously this does not have to be a purpose built building.

We also consider Darlington for Culture and other interests in taking over the running of the facility has commercial merit providing TUPE obligations are set aside.

#### **Parish Council Grants**

Unlike others who receive grants, residents in rural wards provide a large income to the Borough Council via Council tax. In the current financial year that figure will be almost £7 million. The parish grant is £35000 only, that is 0, 51% of that income. The grant is used to provide facilities in the villages that are not provided by the Borough Council and the removal of the grant will result in inequality between rural and urban residents.
