## **Purpose of Report**

1. To amend the membership of Committees for 2006/07 as approved at the Annual Council meeting following the resignation of Councillor Maybrey from the Conservative Group.

## **Background**

- 2. The membership of the Council's Committees reflects the political composition of the Council in relation to 'Counting Committees'. The Council's 'Counting Committees' are Cabinet and Planning, General Licensing/Licensing Act 2003 and the five Scrutiny Committees.
- 3. As Councillor Maybrey has resigned from the Conservative Group and become an Independent Member of the Council, the number of seats the Conservative Group is entitled to on the 'Counting Committees' has reduced from 25 to 23 places. The places the Conservative Group has on the General Licensing Committee/Licensing Act 2003 Committee and the Environment Scrutiny Committee have each reduced by one.
- 4. As an Independent Member Councillor Maybrey would take the seats on the Committees mentioned in paragraph 3 above.
- 5. The revised membership list of Committees is attached as an **Appendix** to this report.
