ANNUAL REPORT OF THE LOCAL ADMISSIONS FORUM

SUMMARY REPORT

Purpose of the Report

1. To update Members of the work of the Local Admissions Forum and to receive its annual report, for information.

Summary

- 2. The Local Admissions Forum is a mandatory body. Its membership comprises Headteachers and governors from community, trust, voluntary aided schools and Academies. The Forum is constituted to make sure that all publically funded schools cooperate and subscribe to the co-ordinated admissions scheme, which must be administered by the local council.
- 3. Admissions Forums have an important power under Section 85A(1a) of the School Standards and Framework Act (1998) to publish an annual report. The report is part of the mechanism by which authorities show their admissions policies are open and fair. The Local Admissions Forum received the annual report at its meeting on 12th November 2008.
- 4. The report provides an objective analysis of the degree to which local admission arrangements support fair access. The Schools Commissioner undertakes a biennial national review of fair access, based on national data and information presented in Forum reports. The Commissioner's report will be presented to Parliament in April, 2009.

Recommendations

- 5. It is recommended that Members :-
 - (a) receive the report for information; and
 - (b) request the Director of Children's Services to have the report made available on the Council's web-site.
