- 5. All Members are aware of the ambitious programme of change across the Council, and a key role of Scrutiny is to ensure that the programme is able to deliver the service improvements and the budget savings necessary and Members need to take this into account when considering their work programmes and ensure that any work focuses on delivering outcomes rather than service delivery.
- 6. Taking the above into account, at the meeting of this Scrutiny Committee held on 5th September, 2011, Members identified the following areas where they would like to focus their work over the next Municipal Year and Terms of Reference (**Appendix 1**) have been developed for each of these topic areas to demonstrate how Scrutiny will undertake the work and what the anticipated outcome may be :-
 - Looked After Children and the role of the Corporate Parenting Panel.
 - Behaviour Strategy for Key Stage 1 and 2 and Key Stage 3 and 4.
 - Child Poverty and Vulnerable Children.
 - Early Intervention and Children and Families Service.
 - Attendance at Key Stage 1 and Reception.
 - Extending Participation in Education and Training to 18 years.
- 7. Children and Young People Scrutiny Committee is therefore requested to consider the attached Terms of References and make any amendments or comments thereon, prior to approval.
- 8. The inaugural meeting of the Review Group to examine Attendance at Key Stage 1 and Reception was held on 17th October, 2011 and the terms of reference for that review were considered. There is a separate item on today's agenda to provide a progress report and to approve the terms of reference.
- 9. If, during the course of the year, Members wish to add any topics to the above, taking into account the comments in paragraph 5, a Quad of Aims will need to be developed and submitted prior to the item being brought to Scrutiny Committee, to ensure that it does contribute to the strategic aims of the Council.
- 10. Children and Young People Scrutiny Committee will also have to consider reports contained within the Budget and Policy Framework which may appear on the agenda as and when required. A Quad of Aims will not be prepared for these items as they are required to be considered by Scrutiny Committee in line with the Constitution.
- 11. Members are also requested to consider Cabinet's Forward Plan, which is available on the Council's website, to assist in determining any further items which they might wish to include on their work programme.
