ANNOUNCED INSPECTION OF SAFEGUARDING AND LOOKED AFTER SERVICES

SUMMARY REPORT

Purpose of the Report

1. To inform Members of the outcome of the Ofsted inspection of 'Safeguarding Services and Provision for Looked After Children. The inspection identified key strengths and areas for improvement immediately, within three months and within six months.

Summary

- 2. The purpose of the inspection is to evaluate the contribution made by relevant services in Darlington towards ensuring that children and young people are properly safeguarded, and to determine the quality of services for looked after children and care leavers.
- 3. Learning and experience from this process will help shape our future priorities over the forthcoming months, in the improvement of outcomes for children in Darlington.

MAIN REPORT

Introduction and Background

5. The inspection assessed services provided individually and jointly by Darlington Borough Council; County Durham and Darlington NHS (Primary Care Trust); County Durham and Darlington Foundation Trust; Tees, Esk and Wear Valley Foundation Trust; Durham Constabulary; and, any voluntary or private sector providing working with children and young people in the Borough.

The Approach

6. The inspection focuses upon safeguarding outcomes for children and young people and services for looked after children and care leavers. This is then broken under specific subsections which focuses attention on the following themes:

- (ii) Capacity for improvement
- (iii) Children and young people are safe and feel safe
- (iv) Quality of provision
- (v) The contribution of health agencies to keeping children and young people safe

- (ix) Partnership working
- (x) Equality and diversity

- 7. The inspection process was undertaken over a four week period, with information, internal case file audits, and young people's consultations being completed within the two weeks

prior to the inspection team's arrival. The inspection team then commenced their on-site work the week beginning 14 of November, for a further two week period. The inspection team comprised of four of Her Majesty's Inspectors and one inspector from the Care Quality Commission.

- 8. The evidence the team gathered included key documents, policies and performance information, questionnaires and information from discussions with children, young people and parents receiving services, focus groups and individual interviews with senior officers, Elected Members, and frontline professionals from both Darlington Borough Council and key partners. The inspection team also evaluated the internal case file audit, completed prior to Ofsted's arrival, and a review of an additional fifty case files. This was to assess the quality of reporting, recording and decision making. The outcomes of the most recent unannounced inspection of local authority contact, referral and assessment services was also included as part of the evidence.
- 9. The inspection team provided daily feedback of their observations, and identified additional documentation they required as evidence. At the end of the fortnight, a feedback meeting detailing their findings was undertaken.

Outcome of the Inspection

10. Overall, the inspectors judged service provision to be adequate. Out of the eighteen outcomes judgements made, nine were graded as good and nine were graded as adequate.

- 11. The report identified the following as areas performing strongly:

 - (iii) 'outcomes for children and young people are good.
 - (iv) Young people generally feel safe in Darlington'
 - (v) 'safeguarding outcomes in services and settings inspected by Ofsted are good, and good education provision promotes the attainment and well being of pupils from vulnerable groups'.'
 - (vi) 'safeguarding children and young people is a high priority in Darlington...During a period of financial constraint and significant reduction in budgets, services to the most vulnerable children, young people and families have been protected'
 - (vii) 'safeguarding performance indicators have improved and most are above the national average'
- 12. The areas for improvement identified by Ofsted for action immediately, within 3 months and 6 months, together with other issues identified throughout the body of the report are attached at **Appendix 1**. Action plans have been produced for each.

Conclusion

- 13. The inspection identified key areas of good partnership working and especially good outcomes for the children and young people in Darlington.
- 14. The next area of priority will be the implementation of the action plan to further strengthen safeguarding services and provision for children and young people and their families.
