SCHOOL ADMISSIONS 2009/2010

SUMMARY REPORT

Purpose of the Report

1. To update Members on the current 2009 intake for school admissions for both primary and secondary schools across Darlington.

MAIN REPORT

Information and Analysis

- 4. The Local Authority acts as a 'clearing house' for all applications for a place at a primary school in Darlington. This is part of a co-ordinated scheme where the Local Authority is the admissions authority for community, voluntary controlled schools and acts on behalf of the admission authority of voluntary aided schools, for the Borough. The Authority will make a single offer of a school place each academic year, to parents who have expressed a preference for their child to be admitted to a maintained school within Darlington. Although all applications will be considered on an equal weighting basis, should a child be eligible for a place at more than one school, parents/carers are requested to rank their order of preference on the 'Primary/Secondary School Admissions Form' in order that only one offer will be made. The relevant admissions criteria will be applied to all schools that are oversubscribed.
- 5. The Local Authority operates a co-ordinated scheme for the majority of school applications, although the Governors Voluntary Aided Primary Schools and the Governors of Hurworth School, Carmel College and Eastbourne Church of England Academy act as the Admission Authorities for their own schools.
- 6. The equal preference system operates to give parents choice in their selection of schools, allocating their highest ranked preference wherever possible.

7. Attached at **Appendix A** is a table indicating the preference data for secondary school intake and primary school intake, for 2009 admission round. Both tables also indicate the current number of appeals received to date, a final figure will be available at the end of June.

Outcome of Consultation

8. During the summer of last year the Admissions Team and Choice Adviser were available at 'Connecting with the Community' sessions held in the market square. It was the first of many opportunities for parents to engage with Children's Services in relation to school admissions. There were also visits to 98% of both primary schools, maintained nursery schools and independent nursery settings across the Authority, open evenings at the

secondary schools in September and the Choice Adviser offered sessions to all schools for
Yr5 children in preparation for the September application process.

9.	These information sessions were held to provide greater support to parents when
	considering their applications for a school place. Initial analysis of the applications
	received would indicate that parents were supported by these information sessions and
	helped to make a more informed choice of a school place.
