SCHOOL EXCLUSIONS 2008/09

SUMMARY REPORT

Purpose of the Report

1. The purpose of this report is to update members of the scrutiny committee with regard to fixed term and permanent exclusions within Darlington for the academic year of September 2008 to July 2009.

Summary

- 2. In the last academic year, 2008-2009, there was a rise in permanent exclusions to 32. This is 8 more than in the previous year. Of these exclusions 24 were from Local Authority maintained schools and 8 from Eastbourne Church of England Academy. Although there has been an increase in permanent exclusions in the last year, the overall trend is downwards. There have been no permanent exclusions from the primary schools. (Appendix A)
- 3. The number of fixed term exclusions in secondary schools has again reduced, falling from 875 in 2007-2008 to 734 in 2008-2009, a 16.1% reduction on the previous year. It is of particular note that Eastbourne C of E Academy has reduced fixed term exclusions from 283 in 2007-2008 down to 82 for 2008-2009 (Appendix A)
- 4. The number of days lost through fixed term exclusion in secondary schools has fallen from 2,285 to 1,940.
- 5. In the primary phase there have been further reductions in both fixed term exclusions and days lost. Fixed term exclusions fell to 60 in 2008 -2009 from 88 in 2007 2008 (Appendix A) and days lost from 209 to 141.

MAIN REPORT

Information and Analysis

- 7. The total number of secondary students who were excluded for a fixed term has fallen to 356 in 2008-09 from 408 the previous year (Appendix B). Schools have been increasingly using alternative sanctions such as internal exclusion and detentions before resorting to fixed term exclusion. Internal exclusion is a more effective deterrent and also ensures students do not miss coursework and are not unsupervised.
- 8. Further co-operation and involvement between the Local Authority and Schools has led to 10 successful managed moves between schools as a positive alternative for students at risk of, or facing permanent exclusion. In these cases schools have given students the opportunity of a fresh start in a new environment. Close collaboration between schools, families, students and the Local Authority has created positive outcomes for these pupils.
- 9. The provision of 6th day education for students who have been permanently excluded has been successfully implemented in Darlington. This has been provided primarily by the Pupil Referral Unit. Many Local Authorities have been unable to meet this requirement.
- 10. The 'Turnaround' provision for primary students has impacted on fixed and permanent exclusions with reductions in both. Turnaround is a new nurture provision for Darlington which opened in January 2009. Children remain on their school roll and attend either morning or afternoon sessions 4 days a week for 3 terms. Parents attend each Wednesday to work with their children and follow a Family SEAL intervention programme. Schools, Turnaround, families and children work in liaison for the best outcomes for the children and their families.
- 11. The majority of permanent exclusions come after an extended period of disruptive and challenging behaviour. This year only 3 students were excluded primarily for a 'one off'

- incident as identified by DCSF guidance as grounds for exclusion. This year 1 exclusion was referred to an Independent Appeal Panel; the governor's decision was upheld.
- 12. 47% of all permanent exclusions were in Year 9. This differs from previous years in that Year 10 also shared a high percentage, whereas this year saw 24 excluded from KS3 and 8 from KS4. This may indicate alternative provision has been being utilised in KS4 and helped to reduce exclusions in years 10 and 11. In KS3 there are fewer opportunities for schools to provide an alternative curriculum.
- 13. The rate of permanent exclusions increased as the year progressed, (Appendix C), this can be attributed to schools persisting longer with students and ensuring a wide range of strategies were exhausted before finally resorting to permanent exclusion.
- 14. The number of fixed tern excluded secondary school students with an active stage of Special Educational Need has fallen from 222 down to 207 (Appendix D), demonstrating that the measures being put in place for extra support have been effective. A drop in those excluded at the school action stage show that school's own internal interventions are having a positive impact.
