#### **REWARD AND RECOGNITION SCHEME**

#### **Purpose of Report**

1. This report provides details of the Reward and Recognition Scheme to be implemented following consultation with stakeholders.

#### **Information and Analysis**

#### Background

- 2. On the 5 June 2007 Cabinet considered a report, which outlined how a Reward and Recognition Scheme could be developed for Council tenants and leaseholders. Cabinet resolved to implement the scheme subject to further detailed consultation (Minute C8(4)/Jun/07 refers).
- 3. The Tenants Board meeting on the 18 July 2007 considered the proposals and agreed to establish a small Task and Finish Group to look at what should be included in the scheme. The group started by researching what other schemes include. All of the schemes looked at have two elements:-
  - (a) Membership criteria Tenants and Leaseholders need to apply to be members and they have to satisfy an eligibility criteria that is a clear rent account or be repaying to an agreed arrangement. Where these criteria are satisfied the tenant/leaseholder is issued a discount card. The discount scheme is operated by a national organisation and gives discount from both national and local shops and companies that are members. The criteria also rewards and recognises good behaviour and there is an element of investing to save. For example, tenants are rewarded by a money payment for giving notice when terminating tenancies, and leaving with a clear rent account and a clean and tidy property and garden. This will reduce the costs associated with re-letting vacant homes and recovering former tenant arrears.
  - (b) Prize competitions a number of prize competitions and other rewards, for example, draws for tenants who pay by direct debit, and good neighbour category.
- 4. The group put together a consultation article, which was included in the November edition of Hotnews. The qualifications for the scheme were set as:-
  - (a) You must be up to date with your rent and pay by Direct Debit.
  - (b) You must have been a tenant for at least three months.
  - (c) Your property and garden must be clean and tidy.
  - (d) You must not have been guilty of any anti social behaviour and agree to sign a Good Neighbour Agreement.

- 5. The benefits of the scheme could be:-
  - (a) A discount card to use in local and national shops, supermarkets and leisure facilities offering a range of discounts and special offers.
  - (b) Entry into regular competitions and prize draws.
  - (c) Faster repairs (including Saturday morning service).
  - (d) Priority over other residents for garage allocation.
  - (e) Low-cost home contents insurance.
  - (f) Good Neighbour and Young Peoples Recognition Awards.
  - (g) Access to seeds to improve gardens and the surrounding environment.
  - (h) Community Chest funding for local groups to further community projects and initiatives.
  - (i) Education grants for members and their families.
  - (j) A welcome package for new tenants to foster good relations and Golden Goodbyes for tenants leaving their homes in good condition and with clear rent accounts.
- 6. Some 60 responses were received, 48 were in favour, 9 against and 3 did not indicate their view. Some of the positive comments made were:
  - "A refreshing change to reward good, not just to punish the miscreants".
  - "I think it is a good incentive for people to take pride in their homes and gardens".
  - "Bearing in mind that the majority of Council tenants are on low incomes, the chance to personally benefit from the dividend scheme would I believe provide the motive to be a good tenant".
- 7. Whilst there was a positive response there were 17 respondents who said that it was unfair that one of the application criteria was that rent had to be paid by direct debit. This had been included as there are considerable financial savings over the costs associated with paying rent by giro. We had wanted to increase the number of tenants choosing direct debit. After discussion with the Task and Finish Group it was decided that this criteria should be removed. It is recommended that as an alternative tenants will be encouraged to pay by direct debit by including tenants who use this payment method in prize draws.
- 8. Proposals for membership were included in the December Hotnews, details of which are attached at **Appendix 1**. A list of local companies recruited to the scheme, which has been named the Darlington Dividend Scheme, is attached at **Appendix 2**. Recruitment does not stop and continues throughout our involvement with the scheme. The Tenants Board was given a number of options for a scheme logo and has selected the design at **Appendix 3**.
- 9. The Tenants Board has also agreed a set of Terms and Conditions for the scheme and these are at **Appendix 4.**

## Proposals

- 10. The February edition of the Hotnews will include an application form for tenants to complete. These applications will be processed and the Darlington Dividend cards issued from the beginning of April. Tenants will be able to apply at anytime and as long as they fulfil the criteria will be issued a Dividend Card. Prize draws of £100 will be held quarterly for tenants who pay by Direct Debit and have a clear rent account at the end of June, September and December. To promote clear rent accounts in time for the end of the financial year there will be a special draw with prizes of £200 and four of £50 for tenants who have clear rent accounts at the end of March. A payment of £150 will be made to all tenants who terminate their tenancies in accord with the scheme, which means four weeks notice, letting procedures can commence, there is a clear rent account, no rechargeable repairs or decoration allowance and the property and garden are left clean and tidy.
- 11. Most of the rewards are for existing tenants and it is also important to offer something to new tenants. It is proposed that new tenants will be able to apply for one hour of time from either the Care and Repair or CABLE handy person service. The handyperson could be used to fit curtain tracks and shelves or do gardening. Also it is proposed to enter all Leaseholders with clear service charge accounts at the end of the financial year in a draw with a prize of £200.
- 12. The Tenants Board are keen to look at developing further rewards and as part of the 2008/9 Service Plan are to consider awards for Good Neighbours. Consideration is being given as to how these awards can include young people living in Council tenancies and leasehold properties. The Board will also be involved in monitoring and evaluating the overall scheme.

## **Legal Implications**

13. This report has been considered by the Borough Solicitor for legal implications in accordance with the Council's approved procedures. There are no issues which the Borough Solicitor considers need to be brought to the specific attention of Members, other than those highlighted in the report.

## Section 17 of the Crime and Disorder Act 1998

14. The contents of this report have been considered in the context of the requirements placed on the Council by Section 17 of the Crime and Disorder Act 1998, namely, the duty on the Council to exercise its functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area. Schemes that promote rewards for looking after property and promoting being a good neighbour and which are not available to those who cause anti-social behaviour, are believed to have a positive impact on crime and disorder.

## Conclusion

15. Following Cabinet's decision to introduce a Reward and Recognition scheme, the Tenants Board have developed eligibility criteria and been involved in the consultation of all tenants and leaseholders. The scheme was well received with the exception of the criteria that required payment of rent by direct debit and this was subsequently removed.

#### Recommendation

16. Members of Neighbourhood Services Scrutiny are asked to receive the report and comment on the proposed Rewards and Recognition scheme.

# **Membership Details – Darlington Dividend**

# To qualify you must:

- 1. Have had a clear rent account for 6 consecutive weeks
- 2. Have an agreement to pay off any rent arrears or outstanding recharges maintained for twelve consecutive weeks
- 3. Have no breaches of tenancy for example anti-social behaviour or untidy garden
- 4. Sign up to a Good Neighbour Agreement

- Saturday morning repair appointments
- A 'Golden Goodbye' when leaving your property
- Garden competitions, good neighbour awards and recognition for young people
