Information and Analysis

- 6. This strategy builds on existing good practice and will deliver integrated services to improve early intervention, prevention and targeted support.
- 7. A key theme throughout is one of empowering young people and places them at the centre of our services, policies and governance.
- 8. This strategy is for all young people aged 11-19 in Darlington. It will ensure that strong universal services including 'places to go and things to do' are available to young people, and that information and support is available where and when they need it in order to help them through what is an exciting but often challenging time of their lives. This will offer a broad framework whilst ensuring that appropriate activities and opportunities are developed for different phases of teenage years.
- 9. The strategy fulfils the national statutory requirement of services for young people and capturing the local context based on a range of data and information about young people in the Borough.
- 10. The strategy also recommends how we will work in partnership with others and commission services from Third sector providers.

Resources

- 11. The actions identified in the strategy will be implemented incrementally over the three year period. Funding for the strategy includes core budget, area based grants, and specific grants. The full implementation of the action plan is subject to the continuing availability of the grants. In Section 10 of the strategy the actions identified all have a statutory basis and in each case the origin of the action is referenced. Some of the nationally determined actions have an implementation plan longer than three years. The actions will be implemented in accordance with the strategic priorities set out in One Darlington, Perfectly Placed, the Local Area Agreement and the Children and Young People's Plan.
- 12. The implementation of the action plan will be monitored through a basket of indicators which include quantitative and qualitative measures. These will include the specific national targets against which grants are allocated. Performance will be reviewed through the Children's Trust Board as well as through departmental procedures, given that many of the actions involve a range of partners.

Outcome of Consultation

13. The draft strategy has been widely consulted upon through the 'Click Stakeholder' group and through other partner and delivery groups. The report has also been to Children and Young People Scrutiny Committee, which invited Darlington's Youth MP to comment upon the draft strategy. Following consultation, the draft strategy was endorsed by the Children's Trust Board on 23rd January, with a recommendation that the strategy be brought to Cabinet for approval.
