SUMMARY REPORT

Purpose of the Report

1. To request Council to consider designating two further training courses in the Members' Training and Development Programme as Mandatory.

Summary

- 2. The Standards Committee at its meeting held on 16th March, 2009 received a report which sought Members approval for the introduction of mandatory training for Members on Safeguarding Adults.
- 3. In addition to this, at the meeting of Cabinet held on 28th April, 2009, Members considered and endorsed a recommendation from the Economy and Environment Scrutiny Committee to introduce mandatory training for all Members of the Planning Applications Committee at the beginning of each Municipal Year.

Recommendation

- 4. It is recommended that
 - (a) mandatory training on Safeguarding Adults be introduced for all Members on a biennial basis (every two years);
 - (b) mandatory training for all Members of the Planning Applications Committee be introduced on an annual basis and that the training be open to all other Members of the Council to attend on a non-mandatory basis; and
 - (c) power be added to (i) of the Standards Committee terms of reference to approve mandatory training courses.

Reasons

- 5. The recommendations are supported by the following reasons:
 - (a) To strengthen the approach to safeguarding adults at risk in Darlington.

- (b) To ensure that Members are fully trained and updated annual on planning matters.
- (c) To ensure that training and awareness raising exists in Darlington.
- (d) To enable the Standards Committee to approve mandatory training courses for Members.

MAIN REPORT

Information and Analysis

Planning Applications Committee

- The Economy and Environment Scrutiny Committee undertook a review of Development Control, following concerns in respect of performance on Best Value Performance Indicator (BVPI) 109 which related to the speed of processing planning applications received by this Council.
- 8. One of the recommendations from that Review was to introduce training for all Members of the Planning Applications Sub-Committee at the start of the Municipal Year and that Members remain exempt from the Committee until such training is completed. The recommendation was considered and endorsed by Cabinet at its meeting held on 28th April, 2009.
- 9. Although the training is mandatory for Members of the Planning Applications Committee it will be open to all other Members to attend on a non-mandatory basis.

Safeguarding Adults

- 10. The Council and partner agencies are strengthening their approach to safeguarding adults at risk in Darlington. Resources have been secured to develop a Safeguarding Team to ensure the effective further development of excellent safeguarding practices.
- 11. The Department of Health is due to report on the outcome of extensive consultation on the policy guidance 'No Secrets' in April 2009. It is widely hoped that this review will strengthen the approaches to safeguarding adults, bringing things more in line with those for Children.
- 12. Training and awareness raising is central to ensuring effective practices exist in Darlington. It is considered good practice for member training to be routinely part of this programme and that all members are required to participate given the responsibilities the council has to protect adults at risk.
- 13. Adult Social Care is due to be inspected by the Commission for Social Care Inspection (CSCI) between April and August 2009. A key theme for the inspection will be safeguarding. It is important that we are able to evidence the positive work going on in Darlington in respect of Safeguarding Adults.
- 14. A report was submitted to the Standards Committee meeting held on 16th March, 2009, and it was agreed to recommended to Council that Mandatory training on Safeguarding Adult responsibilities be introduced for all Members on a biennial basis.
- 15. Standards Committee currently has responsibility for monitoring attendance at training and to ensure that decisions on mandatory training are linked to enforceability. The Standards Committee could approve future decisions of this nature.

Outcome of Consultation

16. There has been no consultation in relation to this matter.
