Background Context

Disabled Facilities Grant (DFG)

- 1.1 The principle legal provisions are contained in the Housing Grants, Construction & Regeneration Act 1996 (HGCRA) and regulations made under it. The following is a summary of the key legal provisions:
 - DFGs are mandatory grants and are available to Disabled People when works to adapt their home are judged necessary and appropriate to meet their assessed needs, and when it is reasonable and practicable to carry them out having regard to the age and condition of the dwelling or building.
 - DFGs are also subject to a means-test (except in the case of children), which means that applicants' and partners income and savings have to be assessed to determine the amount of any contribution they are required to make towards the cost of the required work, and hence the amount of grant available to them. The way in which the means-test is carried out is set by regulations and the Council does not have any discretion in applying it. Applicants in receipt of certain specified benefits are; however, exempted.
 - Subject to all the eligibility criteria (outlined in section 4 of the full of DFG Policy) being met, the Council must 'determine' (i.e. approve) properly made applications 'as soon as reasonably practicable', but no later than 6 months from the application date.

 The maximum DFG is currently set at £30,000 as determined by The Disabled Facilities Grants (Maximum Amounts and Additional Purposes) (England) Order 2008

What stage has the EIA reached?

This is important to note that this EIA should not be considered in isolation and must be reviewed alongside the previously completed EIA for the strategic review and remodelling/recommissioning of the Home Improvement Agency Service. The above EIA directly considered the potential impacts from the introduction of a system of prioritisation for DFG Applications with all Disabled People who had previously received a DFG within 12 months of the consultation or were receiving a DFG at the point of the consultation.

It is important to note that the intention of the DFG Policy is to provide a clear reference guide which details the process followed by Darlington Borough Council with regard to DFG applications and, it is not reflective of any change to existing practice. In order to make the DFG Policy information as accessible as possible as part of the EIA consultation, a summary version of the DFG Policy and a plain English version of the Policy have both been produced. Information was also issued detailing the opportunities for information to be provided in alternative formats via the Corporate Information Service.

If the Consultation Draft Policy is agreed the intention is to implement with immediate effect.

Engagement Methodology:

As detailed earlier, the engagement methodology builds on previously obtained client consultation information and EIA which was undertaken on the service review of the Home Improvement Agency through which all recipients of a DFG in a 12 month period (supplemented by additional individuals who were commencing DFG works at the point of the Equality Impact Assessment)

This previous EIA was the first stage, to inform the development of the Consultation Draft DFG Policy.

The engagement methodology was supplemented by, written requests to the local voluntary organisations representing the key potentially impacted protected characteristics groups of Older and Disabled People to invite a response on behalf of their members.

Current contractors delivering support services to people with a learning disability and/or physical and sensory impairment were contacted to ascertain any arising impacts from the Consultation Draft Policy. (Please refer to Appendix 1 for a copy of the EIA consultation documentation). Reminder information and a full recirculation of the Consultation Draft of the DFG Policy was sent at the mid way point of the consultation.

In addition in order to effectively capture the diversity of DFG applicants and the potential arising impacts from individuals living within different parts of the Borough and across accommodation tenures, the DFG Policy consultation was sent to selection of private sector landlords and Housing Associations.

An online impact assessment questionnaire was also available for completion via the current consultation section on the DBC website.

Section 6: Engagement Findings

The information obtained from the previously completed EIA on the strategic review of the Home Improvement Agency, which considered "What would the potential impact (positive or negative) be if there was a waiting list system, with priority given to urgent cases (e.g. to support a hospital discharge) for Disabled Facilities Grant? (This may mean that some people experience a delay.)

Through this impact assessment the following points were raised for clarification/consideration in the current consultation Draft of the DFG policy.

- The legal time frame for the Council to provide a decision from the date of application, with payment of the grant no later than 12 months from the date of application. Any system of prioritisation would adhere to the time scales as detailed within **Housing Grants**, **Construction and Regeneration Act 1996**.
- More detail of the criteria for prioritisation needed.
- A delay could put clients at higher risk of falls and neglect.
- Delay might lead to increased admissions to hospital and additional pressure on Social Care and Housing for individuals in need of urgent alternations.
- If you weren't urgent when would you become a priority?
- There will always be hospital discharges.
- People may have been struggling at home for long time before making contact with the service. People may be in pain and discomfort whilst they wait.
- Everyone could be urgent, it is only urgent for the person.
- You may have a progressive illness and have to wait a long time, how would people know how you were?
- May have to cope longer with insufficient equipment.
- There was particular concern from individuals whose adaptations related to access to toilet and washing facilities. (Relating to maintaining dignity)

In response to the findings from the above named impact assessment, the following mitigation actions were identified:

- Any system of prioritisation would occur following a full Occupational Therapy assessment which would take account of presenting needs and risks.
- Consideration will be given to any interim measures which could be implemented while an individual was on the waiting list.
- Individuals would be informed to keep in touch and advise if their circumstances change, in addition to this a review of the waiting list will be introduced by Occupational Therapists.

These mitigation factors have been incorporated into the Consultation Draft DFG Policy as detailed below:

- "6.6 If the number of clients waiting for a DFG far exceeds the limited budget available for the provision of adaptations, clients will be placed on a waiting list and dealt with in strict date order to ensure fairness and transparency. Clients must be approved or refused within 6 months of the application date.
- 6.7The waiting list will be reviewed on a monthly basis to identify changing need by the Occupational Therapy Team. If a client feels their needs have become urgent they can also approach a member of the Occupational Therapist (OT) team for review.
- 6.8 Where a client has an urgent need identified by the Occupational Therapy Team, their referral will be dealt with as a priority. A decision regarding this priority is only made after a detailed risk assessment is carried out by a member of the Occupational Therapist (OT) team.
- 6.9 Clients will receive written confirmation of the receipt of the referral from the Occupational Therapy Team and will also be kept informed of their progress on the waiting list by the provider."

The engagement methodology for the EIA on the Draft DFG Policy was supplemented by, written requests to the local voluntary organisations representing the key potentially impacted protected characteristics groups of Older and Disabled People to invite a response on behalf of their members. Specifically in relation to the EIA on the Consultation Draft DFG Policy, two responses were received in the consultation period. The first did not identify any particular impacts for their organisation or the individuals who they represent. The second response highlighted a number of points, which included:

- The delivery arrangements for DFG's would benefit from further clarification covering commissioned support provision and independent arrangements.
- The process for completing applications to be further defined in the Policy.

An online impact assessment questionnaire was available for completion for the duration of the consultation period via the current consultation section on the DBC website.
