#### ADMISSIONS TO SCHOOLS: SEPTEMBER 2010

### SUMMARY REPORT

## **Purpose of the Report**

 The purpose of the report is to inform members of the Scrutiny Committee about the placement of pupils in Reception Classes and Secondary Schools for the 2010-11 school year.

# **Summary**

- 2. Darlington Council is the Admissions Authority for all Community and Voluntary Controlled schools in the Borough. The Council also acts as the co-ordinating authority for admissions to Voluntary Aided Schools, Foundation Schools and Academies. Through the co-ordination arrangements, families receive one offer, and one offer only of a school place for their child on national offer day.
- 3. The numbers of parents receiving a place at one of their named preferences is higher than the national and local averages.

#### MAIN REPORT

## **Information and Analysis**

- 5. There is a diverse community of schools in Darlington, comprising Community Schools, Voluntary Aided (faith based) schools and an Academy. The Council has a duty to run a co-ordinated admissions system for all schools.
- 6. Every year, an Information for Parents handbook is produced, separately for primary and secondary schools. The handbooks contain information on all of the available schools in Darlington, their admissions criteria and the number of children admitted to the school in the previous year. The handbook also has details of the Choice Adviser and gives parents the opportunity to seek further guidance before expressing a preference for a school.
- 7. The scheme of co-ordinated admissions operates across Council boundaries, so parents are also advised of the process to be followed if they wish to apply for a place in a school maintained by a neighbouring Authority.
- 8. Parents can state a preference for five primary schools. Due to the relatively small number of secondary schools in the Borough, only three preferences are invited for places in Year 7. Preferences are stated in rank order and parents are requested to support their indicated preference with reasons for their choice.
- 9. The Authority uses a computerised system to match all preferences against the admissions criteria for each school. Parents are offered the highest ranked preference they have recorded, consistent with their child meeting the admissions criteria for the school concerned. If it is not possible to offer parents a place in any of the schools they have recorded as a preference, the Authority makes an offer of the nearest available place to the parents' home address.
- 10. When it is not possible to offer parents a school of their preference, they are informed of their right of appeal to an independent appeal committee. Appeals in Darlington are administered through the Director of Resources.
- 11. In the following tables, the published admission numbers (PAN) for each school are shown in the left hand column. These numbers can be contrasted with the actual numbers on roll in Year 7 or Reception Class at the Autumn census point in October 2010. The column titled 'Total Number of Applications' records all the preferences made for a school, whether they were first, second, third, fourth or fifth preferences. The tables also show the number of appeals registered and the number of appeals that were successful.

- 12. The analysis from the preferences stated at the time of allocation gave 92% of families a place at one of the secondary schools of their choice, whilst at primary it was 94%. The percentage of children now in a school of their parents' preference will have increased since there were a number of successful appeals.
- 13. Appeals: There were 88 appeals for a secondary (Y7) place this year. This was an increase on 2009 where there were 74 appeals. This year 36 (41%) were successful whereas last year there were 23 (31%) successful. For a primary (Reception) place this year there were 84 appeals, an increase on last year's 33. This year 6 (7%) were successful whereas last year 3 (9%) were successful.
- 14. The table below shows the number of 1st preferences for each school in the first column whilst the second column shows the percentage of successful first preferences.

- 15. The Authority uses statistics to inform pupil place planning. There are currently sufficient secondary places to meet parental demand. The Local Admissions Forum has been keeping a close watch on the demand for primary places, as, following the national trend, the number of requests for places in the Reception class has grown more quickly than projections indicated.
- 16. The last report written for the Forum gave an indication that the number of places for Reception aged pupils for 2010 would be close to the maximum number of places the Authority had. The total number of preferences made to families totalled 1271, the total number of places the Authority made available was 1275.
- 17. The total number of primary children on roll as of 8th October stands at 1234. The net difference can be accounted for with 32 children having refused a place at a school in Darlington and having accepted an alternative school place, either in private education (9) or at a school in another LA area (23).
- 18. There are still 5 children whose parents have chosen to keep their child in nursery until such time as the school they prefer becomes available or they become of compulsory school age.
- 19. The Local Authority has received a challenge to the admissions criteria from the Office of the Schools Adjudicator for the 2011/12 admission arrangements. This was borne out of an unsuccessful application from the 2010 admissions round. The challenge is centred on the unsuccessful applications from parents in rural locations. In addition, a number of parents have also submitted complaints to the Local Government Ombudsman on the same issue.
