#### DRAFT SPORTS FACILITIES AND PLAYING PITCH STRATEGIES

#### **SUMMARY REPORT**

#### **Purpose of the Report**

1. To seek Cabinet approval for the Sports Facilities and Playing Pitch Strategies for Darlington.

#### **Summary**

- 2. The Government, via PPG17, requires local planning authorities (LPAS) to carry out assessments of open space, sport and recreation facilities as part of their planning process. It requires LPAS to prepare, update and regularly monitor and measure the quality, quantity and accessibility for open space, sport and recreation facilities. These documents provide an assessment of sport and recreation facilities following the work to produce an Open Space Strategy in 2007 which completed the first part of the PPG17 assessment.
- 3. The development of a Sport and Physical Activity Facilities Strategy and new Playing Pitch Strategy will help to support the development of community sport and physical activity in Darlington.
- 4. The two studies will help to shape strategic and detailed planning policies and will provide the evidence to justify the provision of new sport, recreation and playing pitch provision or enhancement of existing facilities. The documents will also be used to help assess the merits of planning applications.
- 5. The strategies are key to achieving outcomes identified within the Healthy Darlington delivery theme in the Sustainable Community Strategy.

#### Recommendation

- 6. It is recommended that Members approve the Action Plans as set out in:-
  - (a) Appendix 1 Section 13 of the Sport and Physical Activity Facilities Strategy, and
  - (b) **Appendix 2** Section 7 of the Playing Pitch Strategy.

#### Reasons

- 7. The recommendation is supported by the following reasons:-
  - (a) To inform the planning process by providing a robust evidence base to inform the priorities for future sports facility and pitch provision and to help guide investment decisions.
  - (b) To support the development of community sport and physical activity in Darlington and help address the health improvement agenda.

#### **MAIN REPORT**

#### **Information and Analysis**

- 8. These two documents have been developed through a steering group focusing on provision of Sports Facilities and Playing Pitches that was initially funded by Sport England and includes representatives from DBC Cultural Services, Children's Services, Planning, NHS Darlington, Sport England and PMP Consultancy.
- 9. The studies include an assessment of need, use, accessibility, quantity and quality of existing provision for a range of indoor and outdoor sports facilities. The approach follows the methodology set out in "Towards a Level Playing Field", published by Sport England and PPG17: Planning for Open Space, Sport and Recreation. This strategy builds on existing good practice and will deliver integrated services to improve early intervention, prevention and targeted support.
- 10. The Sustainable Community Strategy outlines a clear commitment to increasing participation in sport and physical activity across the Borough. The findings of these documents will help to ensure that the quantity and quality of sports facilities and playing pitches meets the needs of the local population now and in the future to maximise opportunities for participation.
- 11. The action plans attached to both strategies are working documents and reflect the aims of the Authority and its partners, however it is recognised that the success of a number of these actions is dependant upon financing and will need to be resourced within existing budgets or externally funded grant bids.
