## MAIN REPORT

### Information and Analysis

1. Contained within this Council's Constitution is a procedure for Scrutiny Committees to call-in decisions of Cabinet. This call-in procedure does not apply where the decision being taken by Cabinet or an Officer is urgent.
2. A decision will be urgent if any delay, which is likely to be caused by the call-in process, would seriously prejudice the Council's or the public interest.
3. The Constitution states that decisions taken as a matter of urgency must be reported to the next available meeting of the Council, together with the reasons for urgency and, given below, are details of such decisions taken since the last ordinary meeting of Council held on 17th July 2008.

C25(5)	Proposal to Amalgamate Dodmire Infant and Nursery School with Dodmire Junior School.	To preserve continuity of management, the statutory process for the closure of the existing schools and the opening of a new primary school needed to begin as soon as possible. (Cabinet Urgent Decision)
C25(7)	Disabled Facilities Grants – Amendments to National and Local Policy	To comply with the new legislation and discretionary powers which were implemented on 22nd May 2008. (Cabinet Urgent Decision)
C52	Central Park – Extension of Co-operation Agreement	In order to retain the confidence of the Development Consortium in the commitment of the Council to deliver the Central Park development, including the timescales required by the University Development. (Cabinet Urgent Decision)
