C106	'Supported People Tender for the Provision of Housing Related Support to Homeless People'	To enable Supporting People to re-tender Lots 1, 2 and 5, which are housing related support services for those affected by homelessness, within the shortest timescales possible, prior to the expiration of existing contracts in April 2010 (Lots 1 and 2), and to enable the provision of a new service (Lot 5) within the same timescales as Lots 1 and 2. (Cabinet Urgent Decision).
C116	'Skerne Park Community Centre Security Improvements'	To enable the grant to be spent within this financial year (Cabinet Urgent Decisions).
C120	'Strategic Review of Funding for the Third Sector'	To give certainty to third sector organisations which allows them to plan appropriately for 2010/11 as the current financial year draws to a close (Cabinet Urgent Decision).
C125	'Tender for the Provision of Accommodation Based and Floating Housing Related Support for Homeless People, those at Risk of Homelessness and Vulnerable Parents'	To ensure contracts are awarded in order that services may be provided from 1 st April 2010 (Cabinet Urgent Decision).
C129(2)	'Land for Replacement Playing Fields'	To allow the negotiations to be completed to enable the University development to proceed on schedule (Cabinet Urgent Decision and Special Urgency Rule).
