YOUTH OFFENDING SERVICE ANNUAL PERFORMANCE

Purpose of Report

1. To inform Members of the Youth Offending Service annual performance position for the year April 2003 to March 2004

Information and Analysis

- 2. The Youth Justice Board (YJB) for England and Wales closely monitors the performance of the YOS on a quarterly and annual basis. The performance is also monitored locally by the Darlington Thematic Partnership (Community Safety).
- 3. The YJB uses 17 Indicators and 13 Performance Measures to assess performance, 11 of these are monitored on a quarterly basis and 2 on an annual basis. The annual Performance Measures refer to reducing burglary and vehicle crime and to reducing re-offending by young people in Darlington.
- 4. The YJB scores and ranks all 154 youth offending services nationally. Darlington YOS has been ranked 1st along with 26 other services for the year April 2003 to March 2004.
- 5. The reduction in burglary and vehicle crime demonstrates an 18% reduction on the 2001 baseline figure.
- 6. The reduction in re-offending has been most significant in relation to work carried out with young people receiving Reprimands and Final Warning interventions. That is, those young people who have found themselves in trouble with the police for the first time. However, it should be noted that the re-offending rates for young people receiving community penalties or custody continues to be high at 94% and 100% respectively, and the YOS continues to work to reduce the number of young people who find themselves in these categories.

7. No consultation was required in the production of this report.

Legal Implications

8. This report has been considered by the Borough Solicitor for legal implications in accordance with the Council's approved procedures. There are no issues which the Borough Solicitor considers need to be brought to the specific attention of Members, other than those highlighted in the report.

9. It is not considered that the contents of this report have any such effect.
