- 7. The Syllabus outlines statutory requirements as well as the links to the Every Child Matters agenda. It also provides guidance on the planning and teaching of RE lessons in Key Stages 1, 2 and 3.
- 8. All voluntary controlled and community schools should use the new Agreed Syllabus for RE to plan their RE delivery starting in September 2008. Governing Bodies of all voluntary controlled and community schools are asked to note that the new Agreed Syllabus must be used from September 2008. Governing Bodies of voluntary aided schools may find the new Agreed Syllabus of interest, although it is not mandatory for them to use it.

Outcome of Consultation

9.	Following extensive consultation the revised syllabus was agreed by the Agreed Syllabus
	Conference on 28 th March 2008. SACRE approved the syllabus on 21 st April 2008.
