#### MAIN REPORT

### **Information and Analysis**

- 5. The Office for Standards in Education, Children's Services and Skills (Ofsted) is required by Section 138 of the Education and Inspections Act 2006 to undertake an annual review of each local authority's children's services and to award a performance rating for them. Annual Performance Assessment discharges these duties. This is the last year of APA before the move to Comprehensive Area Assessment. As such the APA process was reviewed to make it a more differentiated and proportionate process, particularly for authorities like Darlington which underwent a Joint Area Review during 2008. The assessment was based on an analysis of data and the authority's own self-assessment/Children and Young People's Plan.
- 6. Attached at **Appendix A** is a letter from Ofsted that summarises the findings of the 2008 Annual Performance Assessment for Darlington. It should be noted that the data profile used to inform the APA judgements is the validated data for 2007, and not data from 2008. This is particularly relevant to school performance where Ofsted notes the good progress made in respect of exclusions, attendance and the achievement of vulnerable groups, but fails to acknowledge the improvements in academic performance in summer 2008 examinations, particularly at Key Stage 4. Although the APA is published after the Joint Area Review, it is based on less contemporary data. The letter highlights both areas of strength and areas for development. Judgements are ranked from 1 to 4 (where 4 is the highest and 1 the lowest). The final judgement scores for Darlington's Annual Performance Assessment are as follows:

- 8. Areas identified for development over the course of the next year include:
  - (a) The progress of schools in achieving Healthy Schools status.
  - (b) The need for local authority children's homes to meet all National Minimum Standards.
  - (c) The number of referrals that led to an initial assessment has decreased.
  - (d) Improve standards in Key Stage 1.
  - (e) Improve standards in Key Stages 3 or 4.
  - (f) Further improve attendance and rates of permanent exclusions.
  - (g) Reduce re-offending rates.
  - (h) Improve opportunities for children and young people with learning difficulties and/or disabilities to influence the shape of local services.
  - (i) Reduce the number of young people not engaged in employment, education or training post-16, including young people with learning difficulties and/or disabilities, young offenders, and 17 to 18-year-olds; and
  - (j) Reduce the proportion of 16 to 18-year-olds whose current activity is not known.
- 9. These will be prioritised for action within the Service Plans of the Children's Services Department and in our response to the recommendations of the Joint Area Review.

#### **Outcome of Consultation**

10. There has been no consultation in respect of the Children's Services APA rating. This is an external judgement of Darlington's Children's Services, subject to national moderation and inspection processes.
