DARLINGTON'S ALLOTMENTS STRATEGY

SUMMARY REPORT

Purpose of the Report

The purpose of this report is to recommend the adoption of Darlington's Allotments
Strategy, the purpose of which is to provide guidance on how the Council's Allotments
Service continues to be integrated within the framework of the town wide allotments
provision, including self managed sites and private sites as well as into the wider local food
movement.

Summary

- 2. An awareness of the need for an Allotments Strategy first arose in 2001 following an Allotments Service Review when a working party was set up to look at how the Council delivered its existing service and how this could be modernised to address a changing environment.
- 3. The main focus of the work plan that came out of the working party was to look at ways of increasing the occupancy rates of allotments and ways of providing higher quality allotment sites. (The existing suite of allotments at the time varied from poor to good with some sites with a very low occupancy levels which reflected the situation across the UK.)
- 4. In addition, the working party identified the need for a process whereby the Council managed sites were handed over to committees in order for them to become self managed associations who collected their own rents and managed most of their own affairs.
- 5. The production of the strategy that is now being put forward sees this work programme consolidated and expanded, and adapted for a rapidly changing market in terms of demand. This strategy will be delivered within existing resources, working closely with the allotments community.
- 6. The delivery of the action plan within the Allotments Strategy in these extremely difficult financial times will require resources to be available both financial and staff.

Recommendation

7. It is recommended that Members agree the attached Allotments Strategy.

Reasons

- 8. The recommendation is supported by the following reasons:-
 - (a) That promoting the continued efficient use of Darlington's allotments provision is a valuable contribution to a number of the key agendas within the Sustainable Community Strategy, namely, health and well being, quality of life, educational achievement and carbon reduction.
 - (b) That the Allotments Strategy will facilitate a much more coordinated approach to providing this service that will see a continued increase in performance and effectiveness.

MAIN REPORT

Information and Analysis

- 9. The details of how it is proposed the Council will run the Darlington's allotments service is contained within the Allotments Strategy. This falls into a number of key areas.
- 10. Firstly the strategy looks at the history of allotments and the part they play in the wider open space provision of the town. This analysis sees the service going from an essential part of certain people's livelihood in the years before the Second World War to a largely neglected service where wide spread dereliction characterised the provision across the UK.
- 11. Secondly, the strategy looks at the Darlington provision as it stands today with the total number of allotment sites set at 26 across the town and approximately 900 plots. This includes Council and private sites. It also looks at the trends that are apparent today in relation to the demand for allotments.
- 12. Next the strategy describes the process of consultation taken place that helped inform the content of this strategy and the conclusions that have been drawn.
- 13. Finally, the strategy draws together a set of conclusions from the data that has been assembled, seeking to address issues gleaned from the past eight years since the working group's paper and combine it with the findings from the consultation process. From this an action plan has been put together that should allow the Council and its partners the opportunity to address the key drivers in the service in the coming 10 years.

Outcome of Consultation

14. The Allotments Strategy has been produced following extensive consultation with all the main stakeholders and partners as well as Resources Scrutiny Committee; the outcome of which is included in the strategy.
