Work Programme for Ordinary and Special Meetings

- 5. Members will be aware that, in accordance with the Scrutiny Procedure Rules, contained in this Council's Constitution, Scrutiny Committees are, subject to the Monitoring and Co-ordination Group's approval, responsible for setting their own work programmes and, in doing so, they should take into account the wishes of all of the Members of that Committee.
- 6. Scrutiny Committees should also take into consideration when considering their work programmes and review topics, the overall effect of the strategic plans of the Council, such as the Sustainable Community Strategy, the Council's budget and the Forward Plan. The work of the Scrutiny Committee should be effective and improve service delivery and this is a clear and overriding process of the scrutiny function. All Scrutiny Committees should also consider the relevant inspection reports, including CPA for their remits.
- 7. Members are therefore requested to consider, as a starting point, the attached draft schedule (Appendix 1) which has been compiled, detailing the proposed dates of meetings of this Scrutiny Committee for the Municipal Year 2009/10, together with details of those plans and strategies which could be considered at each of those meetings and consider whether they would wish to make any amendments thereto.
- 8. Once approved, the draft work programme is not exhaustive as any Member of a Scrutiny Committee can request an item relevant to the function of that Committee to be included on future agendas, in accordance with the provisions contained within the Constitution.

Reviews and Review Groups

- 9. In addition to the work programme for Ordinary and Special Meetings, Members are also requested to consider what issues/topics they would like to review/scrutinise during the Municipal Year 2009/10 and forward their recommendations onto the Monitoring and Coordination Group, for discussion. Again, when considering which reviews and task and finish reviews to undertake, Members should take into consideration, the overall effect of the strategic plans of the Council, such as the Sustainable Community Strategy, the Council's budget and the Forward Plan and take the following into account:
 - a. will the outcome make a difference?;
 - b. any discussion with Chief Officers / Departments on reviews which can be undertaken to assist with the workload of that Department; and
 - c. the local views and priorities what the community would want Scrutiny to get involved in?
- 10. An additional schedule (**Appendix 2**) has been attached which should be completed prior to any review group or task and finish review group being established. The information contained in this schedule will be used to promote the work of scrutiny on the Council's Website and hopefully encourage public participation.
