# 2016/2017 ADMISSION ARRANGEMENTS

#### SUMMARY REPORT

## Purpose of the Report

1. To seek Members' approval for the Local Authority's admission arrangements for the 2016/2017 academic year for all seven maintained schools in the Borough.

## Summary

- 2. In line with the School Admissions Code, an Admission Authority is required to annually determine the admission arrangements used to allocate places for schools for which it is the admission authority **Appendix A.**
- Once approved, there is a statutory duty on the Local Authority to forward the coordinated Admissions Schemes to the Department of Education (DfE) before 1 May 2015.
- The Local Authority is also obliged to formulate Co-ordinated Admission Schemes for both primary and secondary applications to be considered for the 2016/2017 academic year **Appendix B** and must inform the Secretary of State by 15 April 2015.

#### Recommendation

- 5. It is recommended that:-
  - (a) Members consider and determine them as final the Local Authority's admission arrangements.
  - (b) Members adopt the Co-ordinated Admission Schemes for both primary and secondary applications for the 2016/17 academic year.

## Reasons

- 6. The recommendations are supported by the following reasons:-
  - (a) The Authority is under a statutory duty to determine admission arrangements for primary school for which it is the admission authority for the academic year 2016/2017.
  - (b) If the scheme is not approved and returned to the DfE by the 15 April 2015 the Secretary of State may impose a scheme on the Authority.

# Information and Analysis

- 7. The Local Authority acts as a 'clearing house' for all applications for a place at a school in Darlington at the normal point of entry (September). This is part of a coordinated scheme where the Local Authority is the admissions authority for community and voluntary controlled schools and acts on behalf of the admission authority of voluntary aided schools, foundation and Academies in the Borough. Co-ordination also includes the offering of places to children who are resident in Darlington but have stated a preference for a school in another LA area. The Authority will make a single offer of a school place each academic year, to parents who have expressed a preference for their child to be admitted to a maintained school within Darlington. Although all applications will be considered on an equal weighting basis, should a child be eligible for a place at more than one school, parents/carers are requested to rank their order of preference on the 'Primary/Secondary School Application Form 2016/17' in order that only one offer will be made.
- 8. The relevant admissions oversubscription criteria will be applied to all schools that are oversubscribed.
- 9. The equal preference system operates to give parents choice in their selection of schools, allocating their highest ranked preference wherever possible.
- 10. Attached at Appendix B is the Co-ordinated Admission Scheme for both primary and secondary school applications.
- 11. As in the previous year the admissions oversubscription criteria for community and voluntary controlled primary schools will be:

Looked After Children
Medical Reasons
Family Links
Rural
Distance

- 12. Full details of the admission arrangements are provided in Appendix A.
- 13. Where a child has undergone statutory assessment and an Education, Health and Care Plan (EHC) has been issued, the plan will name the school the child should attend. All schools are obliged to admit the child in accordance with the plan.
- 14. Once approved, there is a statutory duty on the Local Authority to forward the Coordinated Admissions Scheme to the Department for Education (DfE) before 15 April 2015. If this does not happen the Secretary of State may impose a scheme on the Authority.
