COMMUNITY SAFETY PLAN 2015-2020

Purpose of Report

1. To propose the Community Safety Plan 2015-2020 (Appendix 1) for Darlington as part of the Council's policy framework and to recommend that Cabinet agrees the Plan and recommends it to Council for adoption (with or without modification).

Summary

- 2. The Community Safety Plan is built around five priorities:
 - (a) Reducing the harmful effects of drugs, alcohol and tobacco;
 - (b) Tackling anti-social behaviour;
 - (c) Reducing offending and re-offending;
 - (d) Working with families with multiple problems;
 - (e) Supporting vulnerable people, (focus is upon domestic abuse, sexual violence and hate crime).
 - (f) The Plan explains the achievements, context, issues and actions in relation to each priority to demonstrate an evidence-based approach. Underpinning the Community Safety Plan is a focus on building strong communities.
- 3. Development of the Plan has occurred in a partnership environment and includes strong input from all key stakeholders. This has been complemented by public engagement work. In the context of huge pressure on public finances, the plan is a summary of partners' aspirations but recognise that constraints during the next five years may impact upon capacity to deliver all of the plan.

Recommendation

4. It is recommended that Cabinet:

- (a) Agrees the new Community Safety Plan 2015-2020 for Darlington;
- (b) Recommends the Plan to Council for adoption (with or without modification).

Reasons

- 5. The recommendations are supported by the following reasons:
 - (a) The Community Safety Plan requires Cabinet's support as it is part of the Council's policy framework.
 - (b) The Plan is based on robust evidence and places Darlington in a stronger position to progress actions around community safety in the current changing climate.

S17 Crime and Disorder	The Community Safety Plan plays a significant part in drawing together activity across the Council and other agencies in order to address both immediate and longer-term issues and solutions.The Plan sets out the Council's commitment to tackling crime, disorder and anti-social behaviour to make Darlington safer.

It is anticipated that this will lead to improved efficiency in a number of areas through the provision of community-based restorative justice work and the continued increase of Neighbourhood Watch, co-ordinated through the Community Safety Partnership.

MAIN REPORT

Context

- 6. Crime, anti-social behaviour, domestic and sexual violence and the impact of substance misuse destroy people lives, blight communities and reduce public confidence. The refreshed Community Safety Plan sets out how stakeholders in Darlington will work together to deliver on five priorities during 2015-20.
 - (a) Reducing the harmful effects of drugs and alcohol and tobacco;
 - (b) Tackling anti-social behaviour;
 - (c) Reducing offending and re-offending;
 - (d) Working with families with multiple problems;
 - (e) Supporting vulnerable people, (focus is upon domestic abuse, sexual violence and hate crime).
- 7. The evidence-based priorities reflect current trends and issues. Specifically, the Community Safety Plan is based upon information included in the Single Needs Assessment and the Police Risk Document, which informs the annual Policing Plan and aims to inform residents and agencies of the key objectives set by the Darlington Community Safety Partnership. The Plan is written at a time of shrinking resources affecting the public sector generally and, at the time of writing, the final detail of future resource levels is not fully known. Therefore, while the Community Safety Partnership is committed to implementing the actions contained within the plan, it is recognised that these are aspirational and may be restricted by reduced levels of funding. Changes brought about through the recent transformation of the Probation Service have implications for the way forward in working with offenders. This said, robust partnership arrangements mean that Darlington is well-placed to deal with the effects of changes as they occur and effective mechanisms are in place to target available resources to ensure that they are being used to deliver the Partnership priorities.

Delivery arrangements

- 8. The Community Safety Partnership Board, endorsed the progress of the draft Community Safety Plan at its last formal meeting in May 2015. The Community Safety Partnership under the leadership of Chief Superintendent Hall and Director of Public Health, Miriam Davidson will be responsible for delivery arrangements. These currently comprise theme groups working on each of the five overarching community safety priorities reporting back into the Community Safety Partnership Board. Each theme group has its own detailed delivery plan. Details of how to access these plans are provided in the relevant section of the Community Safety Plan.
- **9.** A meeting of the Community Safety Partnership Board takes place every eight weeks to progress work around the community safety priorities and consider any budgetary issues or emerging trends.

Consultation

10. Engaging with the public about the development of the Community Safety Plan has been carried out online and via attendance at public meetings. Priorities have been

set taking account of the results of this engagement.

11. Ongoing engagement takes place during the year via Partners and Communities Together (PACT) meetings and public confidence surveys carried out by the Police. This information is used to inform the Single Needs Assessment and in particular the Police Risk document. Increased use of facebook and twitter is being made to inform residents and encourage communication and engagement. New campaigns and consultations are included on the Council website. The Community Safety Plan encourages feedback from residents and provides those who want to become actively involved with contact details so they can get help to improve community safety in their neighbourhoods through volunteering and Neighbourhood Watch schemes.

Equalities

12. The Plan will be progressed through a wide range of programmes, action plans and other activities implemented by the various partner agencies involved in the Community Safety Partnership. The Plan provides the co-ordinating framework directing this wide-ranging activity towards shared outcomes and targets. It is essential that the strategy is implemented in such ways that any outcomes are fair and help advance equality. The Equality Act 2010 requires the Council and other public agencies to "have due regard" in their decisions, services and programmes to eliminating discrimination, harassment and victimisation; to advancing equality of opportunity; and to fostering good relations between people of different backgrounds. The duty applies specifically to age, disability, religion/faith, race, sex, sexual orientation, gender reassignment, pregnancy and maternity, and marriage and civil partnership.

Conclusion

13. This Plan is written in a climate of continuing reduction in resources available for addressing community safety and the constant need to ensure that the Community Safety Partnership can effectively meet the needs of residents in Darlington Commitments within the plan are aspirational and may be restricted by funding levels between now and 2020. This means that it is important that the Community Safety Partnership's key priorities and messages are clearly stated in order to ensure that the Community Safety Partnership is well placed to promote those priorities to the PCC, local residents and stakeholders.
