CYP56. SCHOOL ADMISSION ARRANGEMENTS FOR 2009/10 – CALL IN – Consideration was given to a 'call in' from the Cabinet meeting held on 18<sup>th</sup> March 2008 (Minute C192(2)/Mar/08 refers) requesting further information from the Officers to enable Members to understand how the selection criteria is applied and verified, to understand the mechanisms for record keeping, and to review the Associated Transport Costs.

The Assistant Director – Planning and Resources, Children's Services, informed Members of the application of the equal preference system adopted by this Council in relation to school admissions, the consultation undertaken with the Local Admissions Forum, the verification mechanisms in place to ensure accurate information is provided by parents and that the criteria is applied appropriately, the methodology employed for recording information provided, and the School Admissions Appeals process.

Discussion ensued on the guidance available to parents in providing accurate information, the sanctions open to the Council in cases when false information is provided, the number of cases when false information has been provided by parents,

the hierarchy used as the selection criteria in the equal preference system, the placing of Looked After Children, the selection information provided by the Council to Voluntary Aided schools and Roman Catholic schools in relation to school placement applications, the consideration of specialisms in the selection process, the affect parental choice has on qualifying for associated transport, the implication of parental perceptions in relation to school performance and the selection process, the potential requirement for a greater number of Primary School places, and the recent changes in relation to Appeals Panels and the new Code of Practice.

**RESOLVED** – (a) That this Scrutiny Committee is satisfied with the information provided by the Assistant Director – Planning and Resources, Children's Services, in relation to how the selection criteria is applied and verified, and the mechanisms for record keeping.
