**HP71. QUALITY ACCOUNTS 2014/15** – The Director of Neighbourhood Services and Resources submitted a report (previously circulated) on the Quality Accounts 2014/15 for Tees, Esk and Wear Valleys NHS Foundation Trust and County Durham and Darlington NHS Foundation Trust. Scrutiny Committee’s approval of the Quality Accounts was sought.

The submitted report stated Members had been more involved with the local Foundation Trusts Quality Accounts to enable them to have a better understanding and knowledge of performance when submitting the commentaries on the Quality Accounts at the end of the Municipal Year 2014/15.
