**CYP40. CLIMATE CHANGE AND SCHOOLS** – Dr. Krista McKinsey, Climate Change Schools Project Officer for the Science Learning Centre, North East gave an overview and presentation on the work being undertaken in schools within the North East region in relation to Climate Change.

Following the presentation, those present were divided into two groups and each group considered and shared best practice on what was happening within the Council and their

individual schools in relation to climate change.

The main areas discussed were:-

- experiments taking place at Harrowgate Hill Primary School;
- eco-monitors and eco-champions within schools and an award scheme for recycling at Carmel College;
- recycling initiatives;
- the need to address the issue of recycling of cardboard;
- the Council's Waste Management Contract, including recycling;
- the need for a co-ordinated approach to be adopted by the Council in relation to the collection of recyclable materials;
- environmentally friendly proposals being incorporate in the design for the new build at North Road School;
- the use of woodchip as a 'green fuel';
- School Travel Plans;
- Partnership working between Branksome and Longfield Comprehensive Schools in relation to recycling and obtaining the Bronze Eco Award;
- the possibility of Branksome Comprehensive School becoming a main collection point for composting and cardboard recycling for residents within its area;
- the use of motion sensor lights and taps in some schools;
- assemblies to raise the awareness of recycling; and
- the establishment of a representative group to talk forward climate change initiatives within schools and to share good practice.
