#### NETWORK IMPROVEMENTS AT WEST PARK HOSPITAL AND HUNDENS LANE

#### SUMMARY REPORT

## **Purpose of the Report**

 This report seeks approval from Members for the release of capital funds for IT and network improvements for Darlington Borough Council staff working at West Park Hospital and sharing accommodation with colleagues from Health at Hundens Lane.

## **Summary**

- 2. Council staff working out of West Park Hospital and Hundens Lane have experienced poor performance in relation to accessing critical systems such as Care First and CareStore for example (the current social care case management and document management systems) and in some instances have been unable to access these systems at all. This is impacting upon their ability to work effectively in these locations, and officers are often having to spend time using 'hot-desks' in other locations such as Central House in order to update key IT systems.
- The proposal outlined in this report would improve the network connectivity between these two locations and the Town Hall, enabling staff to work more effectively within their teams and with partners (Tees Esk and Wear Valley Trust (TEWV); and County Durham and Darlington Foundation Trust (CDDFT)) in a colocated operating model.
- 4. The improvements works which includes high speed network connectivity, upgraded telephony and PCs at both sites will cost £57,900 over three years (this includes both capital and revenue costs).

#### Recommendation

5. It is recommended that Cabinet approve the release £24,900 from the capital budget to fund these IT and network improvements and in doing so notes that the ongoing revenue costs for the three year period (£33,000) are already included in the existing revenue budgets.

# Reason

To support Darlington Borough Council's commitment to the co-located operating model with TEWV and the CDDFT based at West Park Hospital and Hundens Lane respectively.

# **Information and Analysis**

7. Officers have undertaken to build a proposal outlining issues currently being experienced by staff at West Park and Hundens Lane in terms of accessing IT systems and applications. The costs for the proposal which includes upgrading the network link to both sites; installing new telephony equipment and new PCs; and cabling works to accommodate the upgraded network and associated power requirements is set out in this report.
