PROPOSAL FOR AN ACADEMY IN DARLINGTON - UPDATE

Purpose of Report

1. To seek Members' views on submitting an Expression of Interest in a City Academy for Darlington to the Department for Education and Skills (DfES).

Background

 A Cabinet report was presented to Members on 1st November 2005 outlining the offer from the DfES to submit an Expression of Interest in the City Academies programme (attached at **Appendix A**). From this meeting, Cabinet referred the request to Lifelong Learning Scrutiny Committee for discussion, debate and recommendations. Lifelong Learning Scrutiny Committee met on 21st November and reconvened on 23rd November, and their recommendations are attached at **Appendix B**.

Information and Analysis

3. The proposal to submit an Expression of Interest in an Academy for Darlington has generated a considerable amount of interest and debate and officers have begun to hold information sessions in various parts of the community. The proposal was debated at a meeting of the Darlington Partnership Board on 9th November 2005, and the partnership agreed to support the proposal. The proposal was also discussed at a meeting of the Darlington Learning Partnership on 23rd November 2005 and this partnership also agreed to support the proposal.

Outcome of Consultation

4. No consultation was required in the preparation of this report as we are at the beginning of compiling the information that will be required for formal consultation. Extensive consultation will be undertaken should the Expression of Interest receive support from the DfES.

Legal Implications

5. This report has been considered by the Borough Solicitor for legal implications in accordance with the Council's approved procedures. There are no issues which the Borough Solicitor considers need to be brought to the specific attention of Members, other than those highlighted in the report.
