#### **COMMUNITY GRANTS 2005/06**

## **Purpose of Report**

1. To consider an application in respect of a Community Grant received from an individual, details of which are contained in the report.

### **Background**

- 2. Members will be aware that from 2005/06 a number of budgets from various Departments have been amalgated to form the new Community Grant. In future the Member with Resource Management portfolio will have delegated powers to make decisions on applications for the new grant after this has been agreed at Annual Council in May. However, a decision on this application needs to be determined before then.
- 3. The Council has made provision within the 2005/2006 revenue budget of £64,000 plus any carry over from 2004/05 before consideration of the attached application.
- 4. Peter Rowley, Director and Chief Executive, of the Darlington Building Society Flora London Marathon scheduled to take place on Sunday, 17th April, 2005 in aid of Four Local Hospice Movements

#### (a) Introduction

A letter of application has been received from the Director and Chief Executive of the Darlington Building Society, for £1,000 in the form of a donation to fund the carer support of the four local hospices, namely St. Teresa's Hospice - Darlington, Butterwick Hospice Care - Stockton-on-Tees, Teesside Hospice Care Foundation - Middlesborough and Hartlepool and District Hospice.

In order raise funds for this cause it is Peter's intention to take part in the Flora London Marathon for 'Help the Hospices' which is scheduled to take place on Sunday, 17th April, 2005. All proceeds from donations and sponsorships from this initiative will benefit the four hospice movements mentioned above.

## (b) Financial Information

The target Peter hopes to raise in aid these hospices is £2,000. At the time of writing he has managed to raise £250 through private sponsorship.

## (c) Previous Applications

Peter and his colleague have applied and been granted financial assistance on one previous occasion. Details and relevant information are highlighted in the table below.
