LICENSING ACT 2003 SUMMARY OF LICENCES GRANTED 01 DECEMBER 2014  
TO 30 NOVEMBER 2015

---

**Purpose of Report**

1. To advise Members of the licences granted in relation to the Licensing Act 2003 for the period 01 December 2014 to 30 November 2015

**Background Information**

2. The Secretary of State's Guidance (paragraph 13.63) issued under section 182 of the Licensing Act 2003 recommends that regular reports be brought to the Licensing Committee detailing where officers have granted licences or certificates in respect of premises and clubs. This is to enable the Committee to have an overview of the licences granted within their district.

**Information and Analysis**

3. Members are referred to **Appendix A** to this report which details all Officer decisions pertaining to the grant of such licences. To assist Members, the premises have been grouped into different categories. Following the receipt of **uncontested** applications Officers have granted a total of **11** Premises Licences (including **5** variations to licence). Officers have also granted **69** applications to vary the Designated Premises Supervisor (DPS), **45** applications to transfer a premises licence, **15** minor variations and **107** Personal Licences in the period detailed at paragraph 1 above. In addition officers have processed **164** uncontested Temporary Event notices (TENS)
4. Members are also referred to **Appendix B (i)** to this report which details **5** Premises Licences that have been granted following a Hearing by a Sub Committee of the main Committee and to **Appendix B (ii)** which details **2** Premises Licences that have been subject to review of licence.
5. The total number of Premises Licences currently issued is **371** and the total number of Personal Licences is currently **940**

**Legal Implications**

6. This report has been considered by the Head of Legal Services for any legal implications in accordance with the Council's approved procedures. There are no issues which the Head of Legal Services considers need to be brought to the specific attention of members.

## **Section 17 of the Crime and Disorder Act 1998**

7. Although one of the licensing objectives of the 2003 Act relates to the prevention of crime and disorder, it is not considered that the contents of this report have any effect in relation to the duty on the Council to exercise its functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.
