Master Plan Meetings ongoing:

Housing	

 A consultation on a new methodology for calculating Objectively Assessed Needs was expected in summer 2017, however no details of this have yet been released. Further delay to the methodology's consultation and eventual publication is a significant risk to the Local Plan timetable. In anticipation of the new methodology, work has begun on identifying the data and variables that are likely to be used in a new methodology and gathering and updating source data. Delay to plan due to OAN methodology.

- Other interventions set out in the Housing White Paper such as the 'Housing Delivery Test' for Local Planning Authorities have also not been confirmed and there continues to be uncertainty regarding which of the proposals relating to development planning will be taken forward and in what timeframe. However, Alok Sharma has been appointed as the new Minister for Housing and Planning.
- Work on identifying sources of affordable and market housing supply for the plan period is on-going.
  The team continues to monitor the progress of sites with planning permission and is researching the
  Darlington specific issues which impact on the timely delivery of developments using data available
  from the upgraded Uniform system.
- Work on maintaining a land register which will become central to effective monitoring and promotion of land in the Borough has been produced. Taking the form of a database and an interactive map, the register will seek to maintain a comprehensive repository of sites to be included in our analysis of potential development sites and those that have been considered in the past. It is intended that this repository will either replace or create links between the several separate but similar datasets which currently exist within the Planning Policy Team, reducing abortive work and the potential for errors and double counting. The Land Register will be used to supply consistent data for numerous statistical returns and requests for information including (amongst others) education projections, the new brownfield register, funding bids and infrastructure planning. It will also be used to inform the TVCA Housing Delivery Plan currently in development. There are currently around 280 sites which have been identified for further analysis,, either my landowners, developers or the Council.

 Gypsy and Traveller needs assessment to be commissioned using new definitions of Gypsy and Travellers. Appropriate consultants being reviewed. Quotes for the work are being considered.

#### **Transport**

Transport for the North (TfN) is developing a Strategic Transport Plan and accompanying TfN Investment Programme to better connect the North of England. To inform this plan some initial reports have been published (June 2017). A brief summary of the key points effecting Darlington are:

• Of the nine Strategic Development Corridors identified. Three are relevant to Darlington:

# o <u>1 - Connecting the Energy Coasts (Multi-Modal)</u>

Better connecting people and goods between the non-carbon energy and research assets located along the North West and North East coastlines and the national road and rail networks. It will also examine providing a more resilient east-west route across the between North of England (this is where the A1/A66 link is being considered).

## 5 - East Coast Corridor to Scotland (Rail)

The East Coast Main Line provides a key spine for north-south movements from which wider strategic and local connectivity is provided, but this corridor also encompasses parallel rail lines connects the key economic centres in the North East of England to each other and to the rest of the UK. This includes potential improvements to Bank Top Station and improved connectivity to Tees Valley.

### 7 - Yorkshire to Scotland (Road)

This complements the East Coast Corridor to Scotland and will examine the requirements to better connect the eastern side of the North beyond the current Road Investment Strategy commitments, also extending into the East Midlands.

Publication of the TfN Strategic Transport Plan and Integrated Sustainability Appraisal for public

consultation is anticipated in the Autumn.

## Other Key milestones:

- A66 North of Darlington Strategic Outline Business Case (SOBC) for DfT to be completed May and taken through TVCA Transport Committee.
- Public Information Event on Strategic Road This will be A66 from A1(M) to Teesport and A19 Tees
  Crossing (delayed due to Purdah) A Darlington event is being planned at Dolphin Centre on the
  afternoon of the 13<sup>th</sup> July 2017 (TBC). There will be other events across Tees Valley Skerningham
  MPF consultations now likely to follow this rather than concurrent.
- Outline Business Case Development (OBC) by Nov 2017. This builds more detail onto the SOBC e.g. modelling, environmental, economic etc.

#### **Education**

Next steps for the group:

- Next theme group meeting to be held 4<sup>th</sup> July PM.
- When consulting and meeting with others (e.g. head teacher meetings, regional and Tees Valley groups) discussions to be documented where they feed into the work for the Local Plan.
- Education to progress baseline information and proposed allocations can be fed into the process. Date to be confirmed.
- Review of funding mechanisms being conducted by Capital/Asset Management Group

#### **Green Infrastructure**

Main themes emerging for next consideration are based around up to date data to provide robust evidence base, consisting of:

- Open space needs assessment update
- Phase 1 mapping up to date and digitized
- Up to date cross reference with other evidence bases and policies; climate change, Energy, Sustainable travel, SuDs, Allotments, which are also in development or revision.

Review of school funding might unlock viability issues.

Report to Local Plan Steering Group. Next steps: • The above is expected to be commissioned externally, such as ERIC undertaking digitisation of Phase 1 and possible sub contract to specialist mapping group for updating under guidance. Wider group to be consulted, this has included greater community representation and smaller interest groups. Need for further breakdown of description of GI designations and what they mean in policy terms, National, local, etc. Along with mapping of green designations at local level, such as Green Wedges, Community Forestry, Local Wildlife Sites (LWS), etc. and how to specifically protect and enhance these and the connection between them. **Town Centre/Retail** Work ongoing to process information received at Town Centre Conference. White Young Green brief prepared in draft for commission to update retail study. (Inception meeting planned Mid July 2017) Consideration will be needed on the potential to accommodate additional out of town retail space without having a detrimental impact upon the existing town centre offer. Retail study commission. Town Centre work shop to be held 21<sup>st</sup> June. Likely direction is a simplified Town Centre policy. i.e. defining Town Centre Boundary largely as is, town centre first principles and then flexibility within the town centre for town centre uses. HELAA Town Centre Workshop 2<sup>nd</sup> HELAA Steering Group Meeting held 13<sup>th</sup> June 2017 Key outcomes:
