#### SUMMARY REPORT

# **Purpose of the Report**

1. To present Audit Services' Audit Plan for 2014/15and associated performance indicators.

# **Information and Analysis**

- 2. Audit Services' Terms of Reference require the Audit Committee to approve the Annual Audit Plan. The Plan for 2014/15 is attached at **Appendix A**. It details work to be undertaken by the Service and reflects an establishment of 4.3 full time equivalent staff.
- The Plan is risk based. It has been developed with reference to corporate and group risk registers and to the identification and prioritisation of auditable areas based on an assessment of their exposure to risk pertaining to the achievement of objectives.
- 4. In assessing the degree of exposure to risk relating to auditable areas, such factors as the following are considered:-
  - (a) materiality (volumes and values of transactions etc. processed by the service);
  - (b) the managerial and control environment;
  - (c) susceptibility to fraud and corruption;
  - (d) outcome from external inspection; and
  - (e) importance in terms of sensitivity and public accountability.
- 5. The Plan has been formulated following consultation with the Chief Officers Executive, Chief Officers Board and External Audit.
- 6. A suite of performance indicators to monitor the operational performance of Audit Services is detailed at **Appendix B**.
- 7. Progress against the Plan and performance measures will be reported to the Audit Committee during the course of the year.

### Recommendation

- 8. It is recommended that :-
  - (a) Audit Services' Audit Plan for 2014/15 at Appendix A be approved.
  - (b) The performance indicators to monitor the operational performance of Audit Services at Appendix B be noted.
